Staff Recommendation: Approve vacation of utility easement.

MAPC Recommendation: Approve vacation of utility easement. (unanimous)

Background: The applicant proposes to construct office buildings on to the property line of the lots in question. These lots adjoin reserves that are available for extension of utilities as needed. The vacation of the 10 foot platted utility easements and the north 5 feet of reserve area will not harm the ability to extend utilities into this area because of the presence of the reserves. All utility representatives thoroughly reviewed this request prior to action by the Subdivision Committee. The homeowner association responsible for the reserve area adjoining one of the lots was notified of the Subdivision Committee meeting, but did not appear.

The Subdivision Committee and MAPC both approved the vacation. No members of the public addressed the MAPC in opposition to this request.

Recommendations/Actions: Close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Vacation Order; recording costs to be billed to: 150029-2909

Staff Recommendation: Approve vacation of alleys.

MAPC Recommendation: Approve vacation of alleys. (unanimous)

Background: The applicants own the entire block in question, most of which is occupied by the operations of Printing, Inc. They wish to increase the on-site, night-time security of their operations by fencing their ownership from access by way of the present alleys. In order to do this, the alleys must be vacated.

The Subdivision Committee and MAPC both approved the vacation, subject to several conditions, all of which have been met. No members of the public addressed the MAPC in opposition to this request.

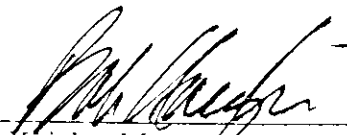

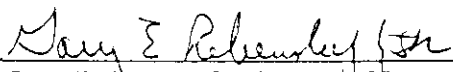
