**Background:** The applicant is requesting to vacate a portion of the drainage easement for construction of a warehouse facility. The bond has been posted for storm water improvements.

Public Works has reviewed and approved this request. The vacation request has been reviewed and approved by the Planning Commission on August 13, 1998, subject to the applicant guaranteeing drainage improvements and dedicating an additional drainage easement.

**Legal Considerations:** The City Clerk needs to certify as to proper notification and no filing of written protest.

**Recommendations/Actions:** Close the public hearing, approve the vacation; adopt the resolution; accept the dedication; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Vacation Order.

Commencing at the Northeast corner of said Lot 1; thence S 00° 10' 25" E, 165.39 feet along the East line of said Lot 1; thence S 22° 14' 08" W, 121.64 feet along the West line of 100.00 feet of the Drainage Easement platted in said addition to the point of beginning; thence S 00° 53' 34" E, 50.35 feet; thence S 89° 06' 26" W, 21.51 feet parallel with the North line of said Lot 1; thence N 22° 14' 08" E, 54.76 feet along the West line of said 100.00 feet Drainage Easement to the point of beginning.

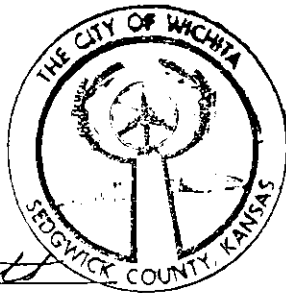
5. The vacation of the a portion of a 100 feet drainage easement described herein should be approved, subject to the following condition:

- B) The applicant needs to guarantee drainage improvements and dedicate additional drainage.

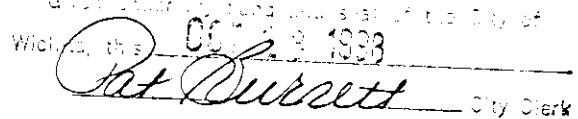
