Staff Recommendation: Approve vacation of a portion of a platted utility easement.

MAPC Recommendation: Approve vacation of a portion of a platted utility easement.

Background: The applicant is requesting to vacate a portion of a platted utility easement. The existing building on-site was constructed over this utility easement, as shown on the attached site plan.

Public Works has indicated that this vacation request is acceptable. The vacation request has been reviewed and approved by the Planning Commission. No members of the public addressed the MAPC in opposition to this request.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Actions: Close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Vacation Order.

NOW on this 22nd day of September, 1998, comes on for hearing the petition for vacation filed by QuikTrip Corporation, Attn: John Dix, praying for the vacation of the following described a portion of platted utility easement, to-wit:

Commencing at the NW corner of Lot 1, QuikTrip 6th Addition, Wichita, Sedgwick County, Kansas; thence N89°43'20"E along the north line of said Lot 1, 101.03 feet to an intersection with the west line of a 20 foot utility easement as platted in said Lot 1; thence S00°00'36"W along the west line of said easement, 6.00 feet for a point of beginning; thence continuing S00°00'36"W along the west line of said easement, 4.00 feet to the SW corner of said easement; thence N89°43'20"E along the south line of said easement, 20 feet to the SE corner of said easement; thence N00°00'36"E along the east line of said easement, 4.00 feet; thence S89°43'20"W parallel with the south line of said easement, 20 feet to the point of beginning.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this one time 9-1-1998, which was at least 20 days prior to this public hearing.

5. The vacation of the a portion of platted utility easement described herein should be approved, subject to the following condition:

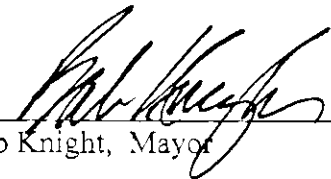
A) Any relocation or reconstruction of any utilities made necessary by this vacation shall be the responsibility of the applicant.

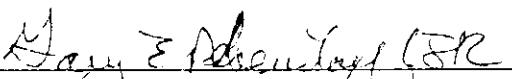

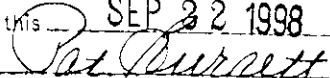
