VACATION ORDER

NOW on this 16th day of June, 1998, comes on for hearing the petition for vacation filed by Twin Lakes National Bank, Attention: Steve Cain, praying for the vacation of the following described building setback, to-wit:

The east 12 feet of the west 111 feet of the north 26 feet of the south 35 feet of the following described tract: Part of Block C and vacated Edwards Avenue in Sandlian's third Addition to Wichita, Sedgwick County, Kansas described as beginning 50 feet north and 605 feet west of the SE corner of the SE 1/4 of Section 12, Twp. 27-S, R-1-W of the 6th P.M., Sedgwick County, Kansas; thence west along the extended south line of said Block C, 183.3 feet; thence north 200 feet; thence east parallel with the south line of said Block C, 153.46 feet; thence southeasterly 46.5 feet; thence west .2 feet along the north line of Rhodes Addition to Wichita, Kansas; thence south 165 feet to the Point of Beginning.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this one time May 22, 1998, which was at least 20 days prior to this public hearing.
2. No private rights will be injured or endangered by the vacation of the above-described building setback, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.

A) Any relocation or reconstruction of any utilities made necessary by this vacation shall be the responsibility of the applicant.

IT IS, THEREFORE, BY THE CITY COUNCIL, on this 16th day of June, 1998, ordered that the above-described building setback is hereby vacated. IT IS FURTHER ORDERED that the City Clerk shall certify a copy of this order to the Register of Deeds of Sedgwick County.
