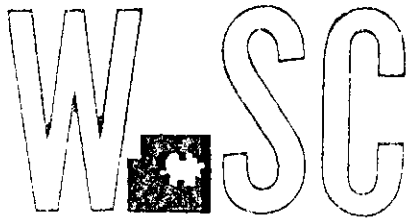

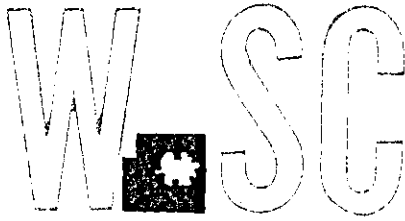

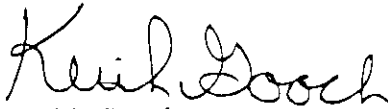
At the regular meeting of the Subdivision Committee of the Metropolitan Area Planning Commission, Thursday, December 10, 1998, the above-captioned vacation request was considered. The action of the Committee was to recommend that this vacation be approved subject to:

- A. The applicant shall dedicate an access easement to Broadway through the parking lot just north of the existing building, prior to this request being scheduled for City Council approval.
- B. The vacated alley shall be retained as a utility easement.
- C. The applicant shall file a hold harmless agreement for the proposed construction over the vacated alley which is retained as a utility easement. The applicant shall meet with the City of Wichita Water Department, prior to this request being scheduled for City Council, to discuss what improvements are needed for the existing water line in the vacated alley.
- D. Per the Traffic Engineer's request the alley shall become a two-way alley.
- E. Any relocation or reconstruction of utilities made necessary by this vacation shall be the responsibility of the applicant.

LEGAL DESCRIPTION: The alley between odd Lots 95-107 Lawrence Avenue, now Broadway, and even Lots 96-108 Topeka Avenue, All in English's 3rd Addition to Wichita, Sedgwick County, Kansas.

LOCATION: East of Broadway and north of Lewis

REASON FOR REQUEST: Redevelop the vacant building on-site

CURRENT ZONING: "CBD"

The applicant is requesting to vacate an alley to allow for the redevelopment of a building on-site.

SUBDIVISION COMMITTEE RECOMMENDS APPROVAL, SUBJECT TO THE FOLLOWING CONDITION:

- A. The applicant shall dedicate an access easement to Broadway through the parking lot just north of the existing building, prior to this request being scheduled by City Council.
- B. The vacated alley shall be retained as a utility easement.
- C. The applicant shall file a hold harmless agreement for the proposed construction over the vacated alley which is retained as a utility easement. The applicant shall meet with the City of Wichita Water Department, prior to this request being scheduled for City Council, to discuss what improvements are needed for the existing water line in the vacated alley.
- D. Per the Traffic Engineer's request the alley shall become a two-way alley.
- E. Any relocation or reconstruction of utilities made necessary by this vacation shall be the responsibility of the applicant.
