Staff Recommendation: Approve the vacation.

MAPC Recommendation: Approve the vacation. (unanimous)

Background: The applicants are requesting consideration to vacate the 20-foot utility easement that runs along their common side lot line, between Lots 7 & 8, Block 2, Graf – Goldston 2nd Addition. There is an existing encroachment on Lot 7, where a swimming pool was built 4-feet deep into the easement for a length of 10-feet. There are no City or Private utilities in this easement. The vacation of the 20-foot utility easement between Lots 7 & 8, Block 2, Graf – Goldston Addition will end at the point of its intersection with the 20-ft utility easement that runs in the south (rear yard) end of Lots 7 & 8, Block 2, Graf – Goldston Addition.

No public or private utility representatives objected to the request and one spoke in opposition to this request at the MAPC's advertised public hearing, and the MAPC voted to approve the vacation, adopting the findings of fact that are incorporated in the Vacation Order. No written protests have been filed.

Legal Considerations: A certified copy of the Vacation Order will be recorded with the Register of Deeds.

Recommendations/Actions: Follow the recommendation of the Metropolitan Area Planning Commission and approve the Vacation Order, and authorize the necessary signatures.

4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.

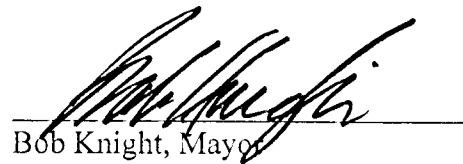
5. The vacation of the platted 20-foot utility easement described herein should be approved.

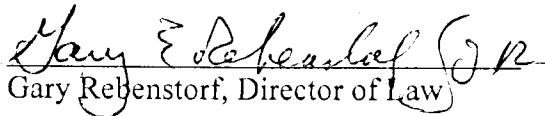

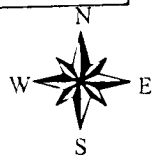
