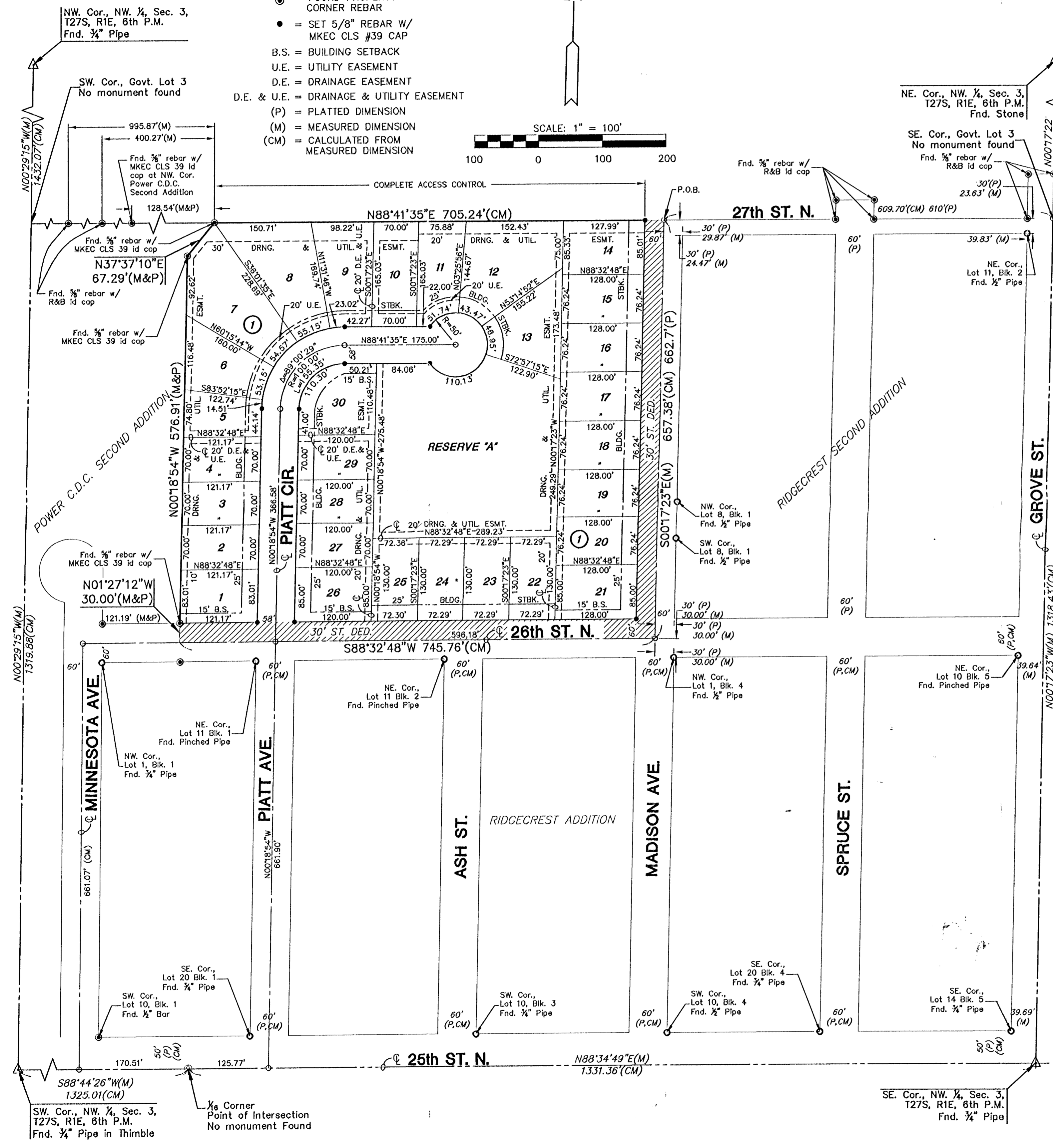
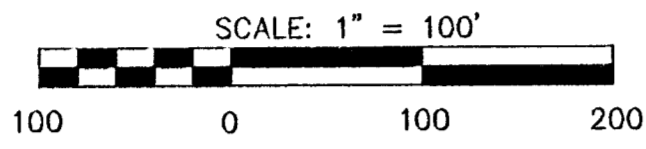
# FINAL PLAT

COMMENCING at the Southeast corner of the said Northwest Quarter, thence on a Kansas South Zone Grid Bearing of N00°17'23"W, 1318.43 feet to the Southeast Corner of Government Lot 3; thence along the South line of said Government Lot 3, S88°41'35"W, 609.70 feet to the POINT OF BEGINNING, said point being the intersection of Madison Avenue and 27th Street North as dedicated by Ridgecrest Second Addition an addition to Wichita, Kansas; thence along the West line of said Ridgecrest Second Addition, S00°17'23"E, 657.38 feet to the intersection of Madison Avenue and 26th Street North, as dedicated by Ridgecrest Addition an addition to Wichita, Kansas; thence along the Northerly line of said Ridgecrest Addition, S88°32'48"W, 745.76 feet to a Southeasterly corner of Power C.D.C. Second Addition an Addition to Wichita, Kansas; thence along the East line of said Power C.D.C. Second Addition, N01°27'12"W, 30.00 feet to the Southeast corner of Lot 23, Block 1, of said Power C.D.C. Second Addition; thence continuing along said East line N00°18'54"W, 576.91 feet; thence continuing along said East line N37°37'10"E, 67.29 feet to the Northeast corner of said Power C.D.C. At the regular meeting of the Subdivision Committee of the Metropolitan Area Planning Commission on Thursday, March 13, 2003, the above captioned plat was considered. The action of the Committee was to approve the one-step final plat, subject to the following staff comments:

- A. The applicant shall guarantee the extension of sanitary sewer and City water to serve the lots being platted.
- B. If improvements are guaranteed by petition, a notarized certificate listing the petitions shall be submitted to the Planning Department for recording.
- C. **City Engineering** needs to comment on the status of the applicant's drainage plan. ***The drainage plan is approved.***
- D. The applicant shall guarantee the paving of the proposed interior streets in addition to 26<sup>th</sup> St. North and the west half of Madison.
- E. **Traffic Engineering** has requested complete access control to 27th Street.
- F. Provisions shall be made for ownership and maintenance of the proposed reserves. The applicant shall either form a lot owners' association prior to recording the plat or shall submit a covenant stating when the association will be formed, when the reserves will be deeded to the association and who is to own and maintain the reserves prior to the association taking over those responsibilities.
- G. The applicant shall submit a covenant which provides for four (4) off-street parking spaces per dwelling unit on each lot which abuts a 58-foot street. The covenant shall inventory the affected lots by lot and block number and shall state that the covenant runs with the land and is binding on future owners and assigns.

- H. The City Fire Department/GIS needs to comment on the plat's street names. *The street names are approved.*
- I. On the final plat tracing, the MAPC signature block needs to reference "Bernard A. Hentzen, Chair".
- J. City Environmental Health has requested that a restrictive covenant be recorded that prohibits the use of water wells on the site for any purpose.
- K. The Applicant is reminded that a platting binder is required with the final plat. Approval of this plat will be subject to submittal of this binder and any relevant conditions found by such a review.
- L. The platting text shall include language that a drainage plan has been developed for the plat and that all drainage easements, rights-of-way, or reserves shall remain at established grades or as modified with the approval of the applicable City or County Engineer, and unobstructed to allow for the conveyance of stormwater.
- M. The applicant shall install or guarantee the installation of all utilities and facilities which are applicable and described in Article 8 of the MAPC Subdivision Regulations. - P. The applicant is advised that various State and Federal requirements (specifically but not limited to the Army Corps of Engineers, Kanopolis Project Office, Rt. 1, Box 317, Valley Center, KS 67147) for the control of soil and wind erosion and the protection of wetlands may impact how this site can be developed. It is the applicant's responsibility to contact all appropriate agencies to determine any such requirements.
- Q. The owner of the subdivision should note that any construction that results in earthwork activities that will disturb one (1) acre or more of ground cover requires a Federal/State NPDES Storm Water Discharge Permit from the Kansas Department of Health and Environment in Topeka. Also, for projects located within the City of Wichita, erosion and sediment control devices must be used on ALL projects. For projects outside of the City of Wichita, but within the Wichita Metropolitan area, the owner should contact the appropriate governmental jurisdiction concerning erosion and sediment control device requirements.
- R. Perimeter closure computations shall be submitted with the final plat tracing.

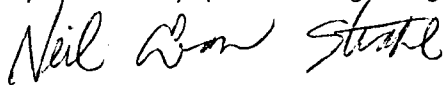
- T. The representatives from the utility companies should be prepared to comment on the need for any additional utility easements to be platted on this property.

If this plat requires the guaranteeing of improvements, a list of the five (5) methods that have been adopted as being acceptable is available in the Planning Department. Also available, are Certificates that are required if petitions are submitted, bond forms and Irrevocable Letter of Credit forms.

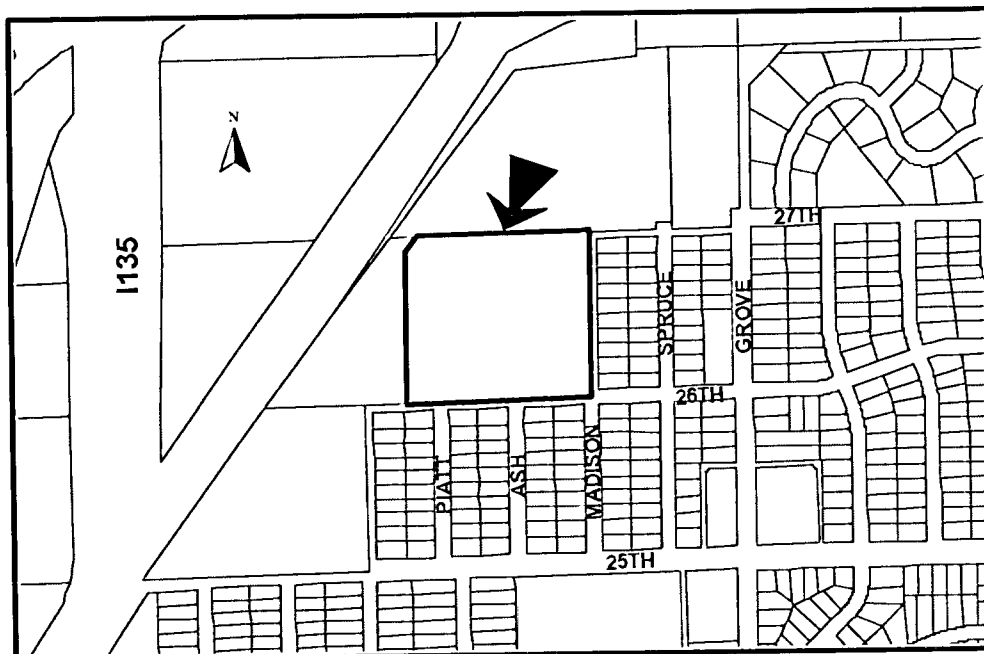
