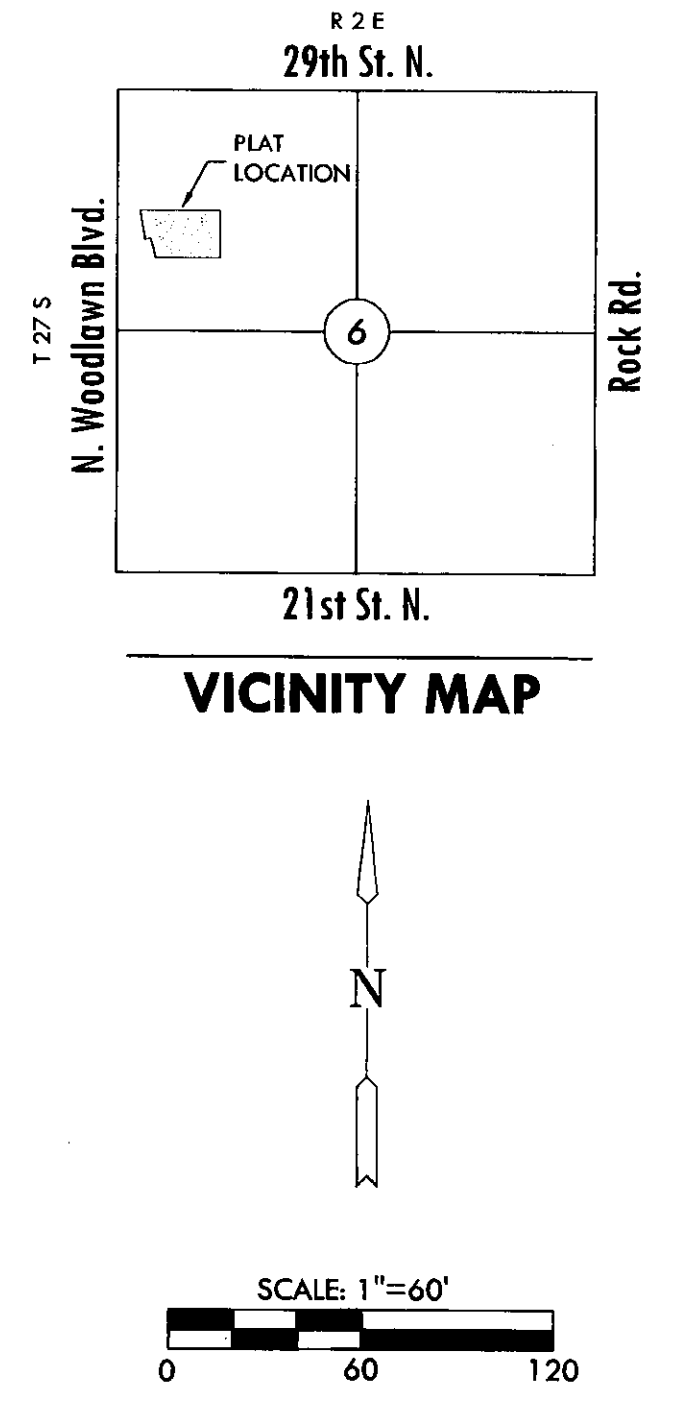
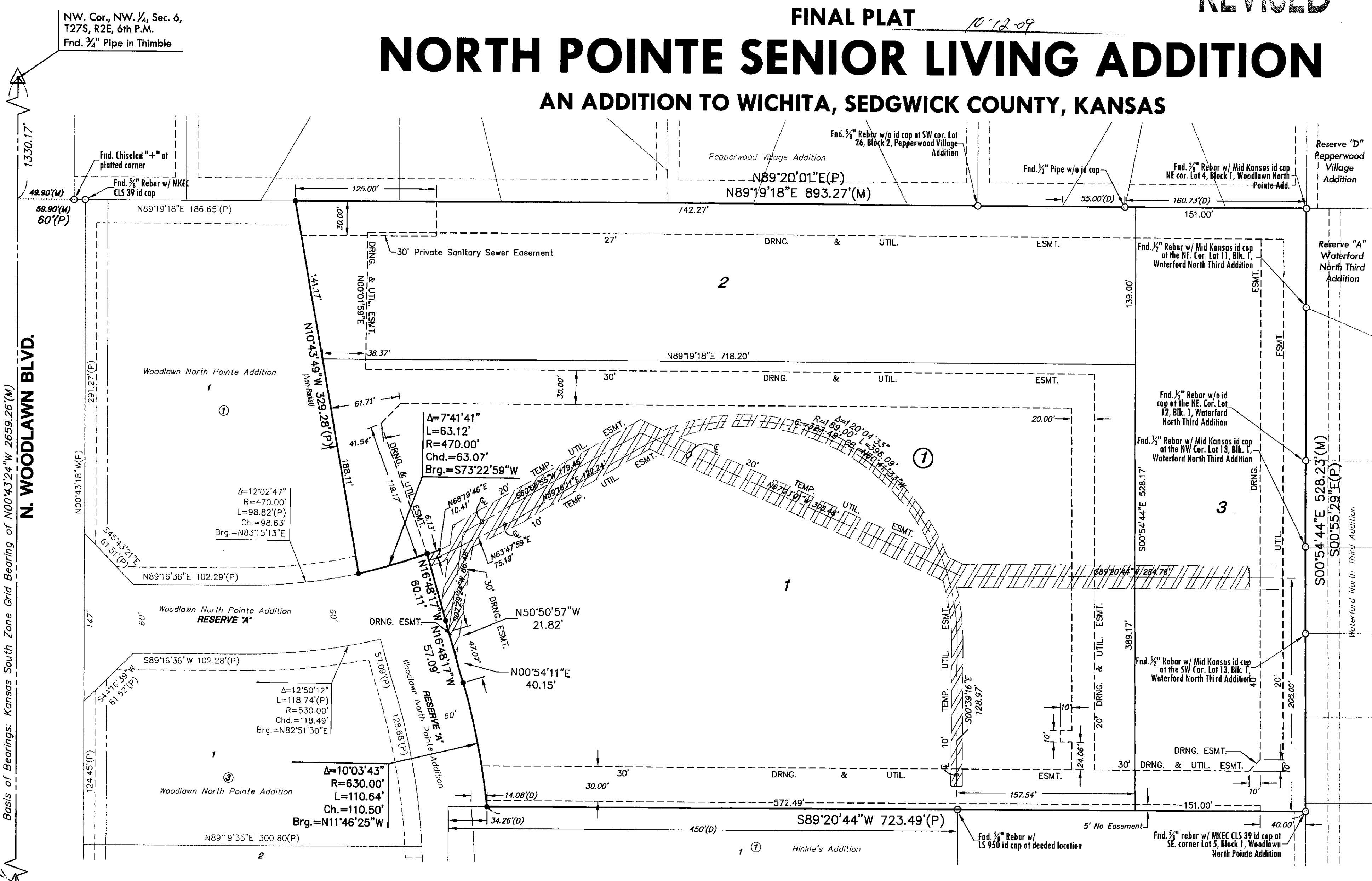

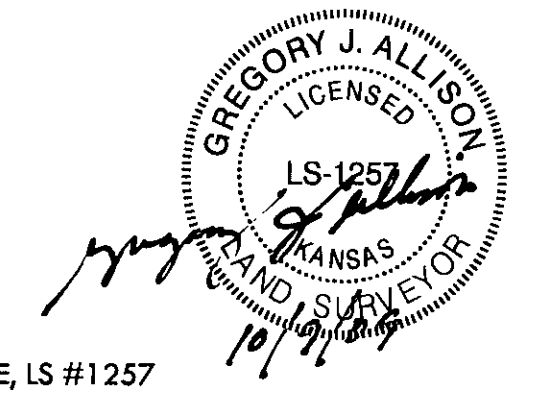
CERTIFICATE OF SURVEY

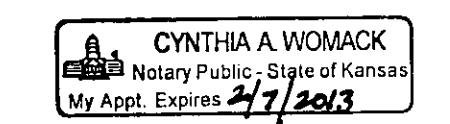

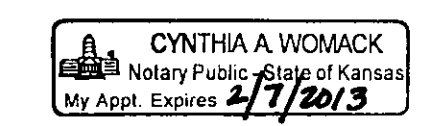
