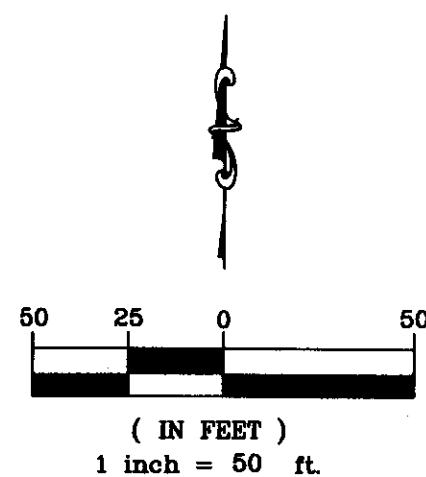
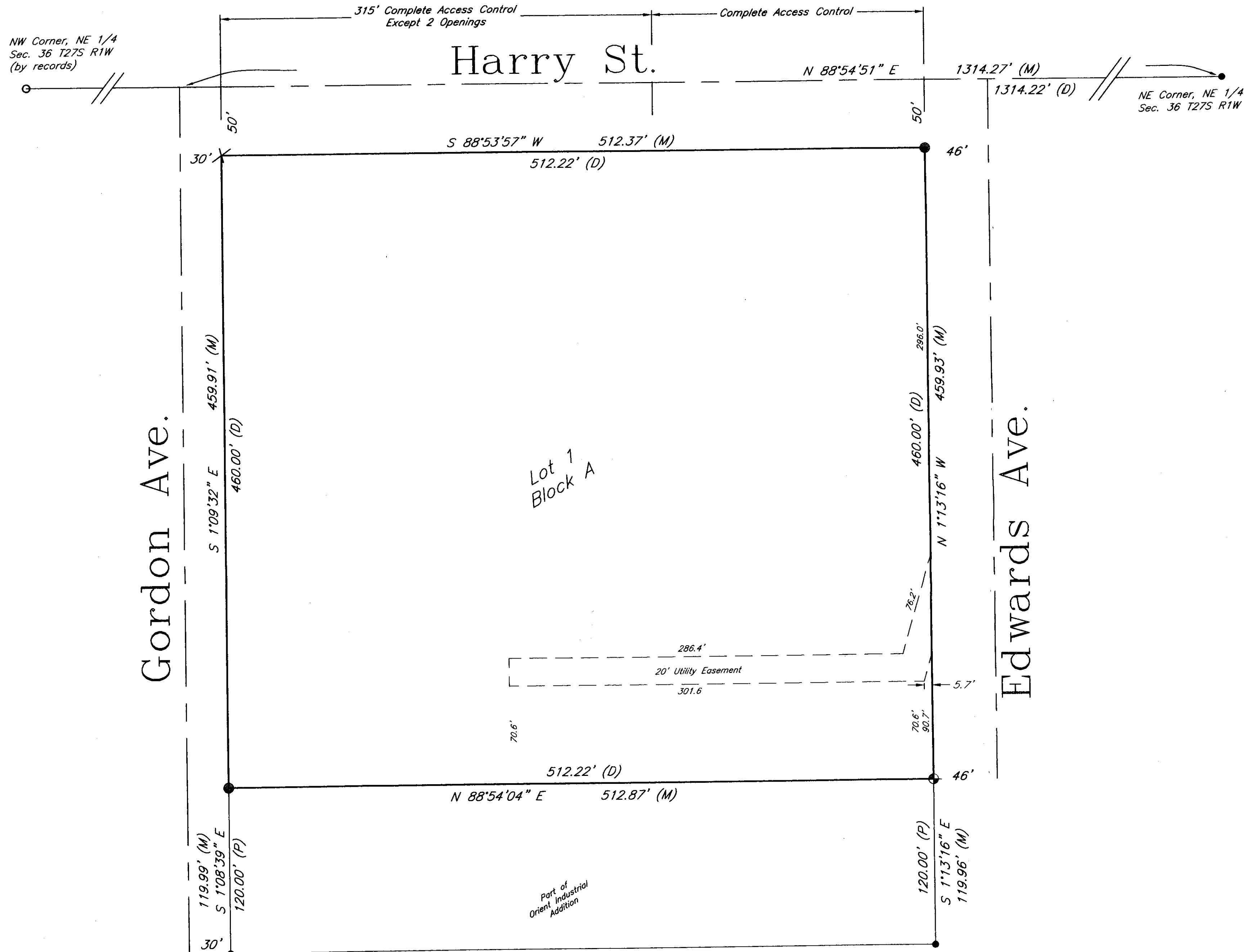


Payne Elementary School Addition

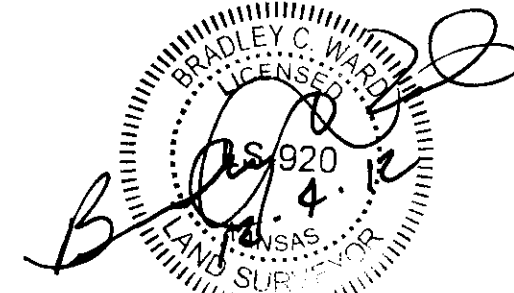

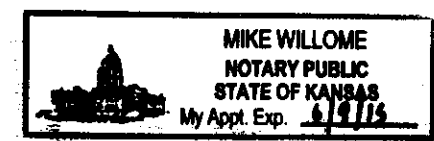
