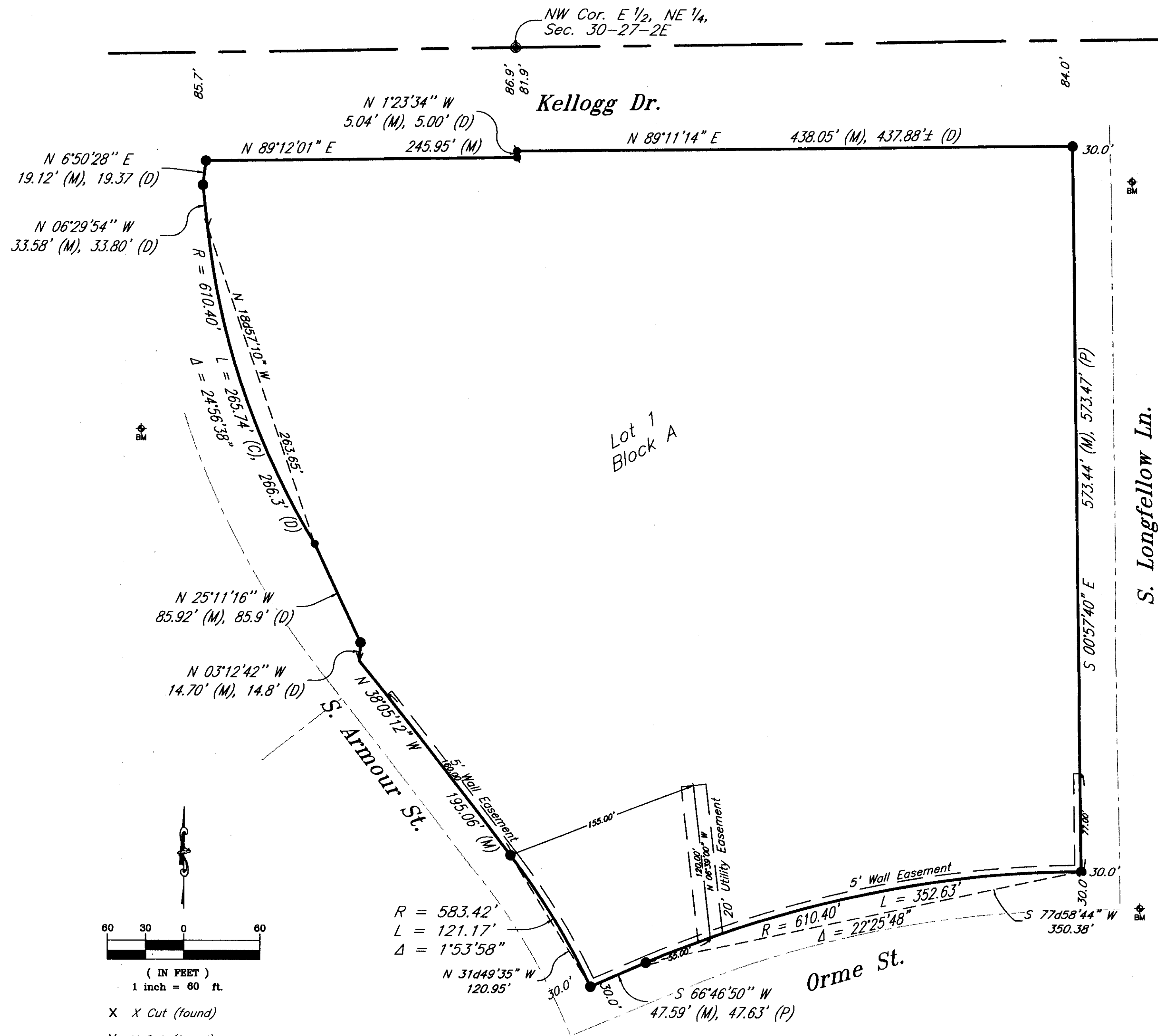

I, Bradley C. Ward, a licensed land surveyor of the State of Kansas, do hereby certify that the following described tract of land was surveyed on the 26th day of September, 2012 and the accompanying final plat prepared and that all the monuments shown herein actually exist and their positions are correctly shown to the best of my knowledge and belief.

LEGAL DESCRIPTION

Parcel 1:
Lot 1, Block 1, Replat of Block 1, Kellogg Crest Addition to the City of Wichita, Sedgwick County, Kansas.

Parcel 2:
Lots 2 and 3, Block 1, Replat of Block 1, Kellogg Crest Addition to Wichita, Sedgwick County, Kansas.

Parcel 3:
Lot 1, East Side Center, an Addition to Wichita, Sedgwick County, Kansas.

Parcel 4:
Lot 4, Block 2, Eastridge Eleventh Addition to Wichita, Sedgwick County, Kansas.

Parcel 5:
Lot 5, Block 2, Eastridge Eleventh Addition to Wichita, Sedgwick County, Kansas; together with the East Half of vacated Doreen Street adjacent on the West.

Parcel 6:
Block 4, Eastridge Eighth Addition to Wichita, Kansas, EXCEPT Beginning at the Southeast corner thereof; thence North along the East line of said Block 4, 105.98 feet to a point 36.24 feet North of the Northwest corner of said Lot 2, Block 1; thence West parallel with the North line of said Lots 2 and 3, Block 1, 31.51 feet; thence Southwesterly 41.68 feet to the Southwesterly line of said Block 4, to a point 87.17 feet Northwest from the place of beginning; thence Southeast along the Southwesterly line of said Block 4, 87.17 feet to the Place of Beginning Sedgwick County, Kansas; AND EXCEPT that part described as: Beginning at the Northwest corner of Block 4, Eastridge Eighth Addition, Wichita, Sedgwick County, Kansas; thence Southeast along the West lot line to a point 435.2 feet (measured along the West lot line) from the Northwest corner of said Block 4; thence Northerly at a bearing of N 04°25'32" E, a distance of 14.8 feet; thence Northwesterly at a bearing of N 24°04'12" W, a distance of 85.9 feet; thence Northwesterly along an arc with a radius of 610.4 feet to the right and a beginning bearing of N 30°20'45" W, a distance of 266.3 feet; thence Northerly on a bearing of N 05°21'08" W, a distance of 33.8 feet; thence Northerly on a bearing of N 08°01'33" E, a distance of 24.4 feet to a point on the North lot line of said Block 4, a distance of 41.6 feet from the Northwest corner of said Block 4; thence Westerly along the North lot line of said Block 4 to the Point of Beginning; AND EXCEPT the North 5 feet dedicated for road.

Parcel 7:
That part of Block 4, Eastridge Eighth Addition to Wichita, Kansas, described as beginning at the Southeast corner thereof; thence North along the East line of said Block 4, 105.98 feet to a point 36.24 feet North of the Northwest corner of said Lot 2, Block 1; thence West, parallel with the North line of said lots 2 and 3, Block 1, 31.51 feet; thence Southwesterly 41.68 feet to the Southwesterly line of said Block 4 to a point 87.17 feet Northwest from the Place of Beginning; thence Southeast along the Southwesterly line of said Block 4, 87.17 feet to the Place of Beginning, Sedgwick County, Kansas.

All easements and Rights of Way within said tract are hereby vacated by virtue of KSA 12-512b amended.

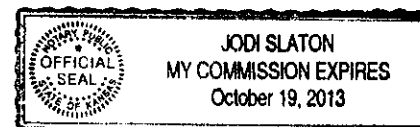

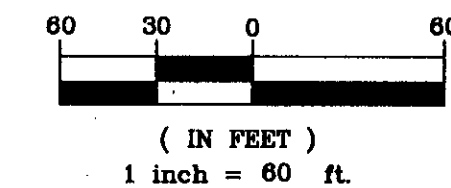
