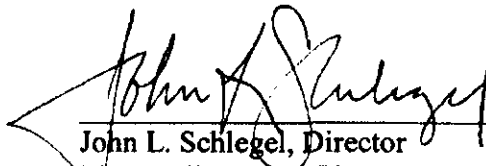

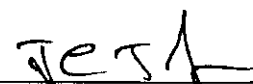
We have reviewed your request and have approved the requested adjustment as described above.

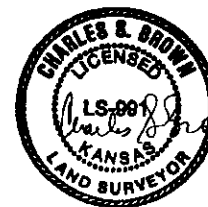

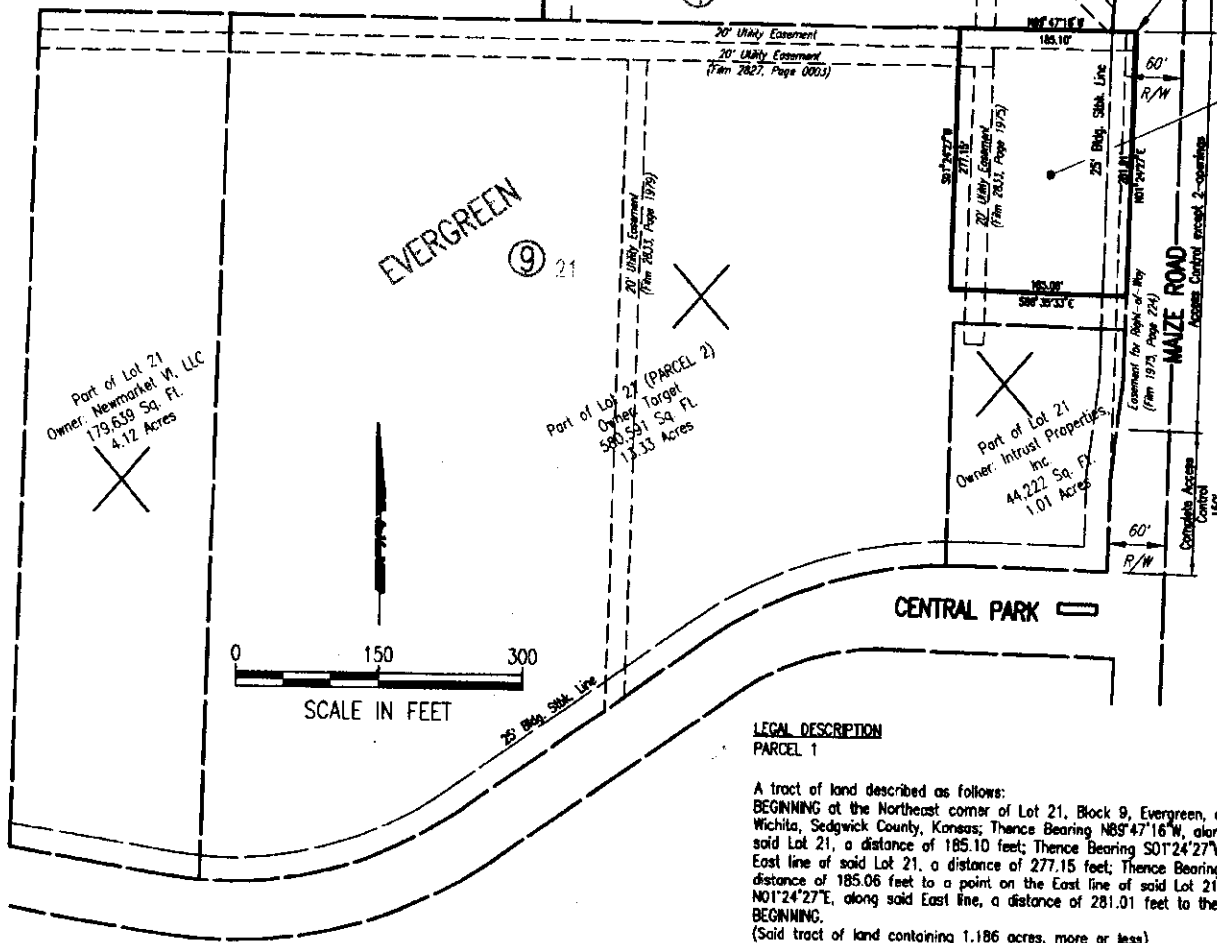
