Commencing at the Northwest Corner of the Northwest Quarter of Section 12, Township 28 South, Range 2 East of the 6th P.M., Sedgwick County, Kansas; thence S 0017°50' E (assumed basis of bearings) along the West Line of said Northwest Quarter for 1965.00 feet to the Point of Beginning; thence N 0017°50' W along said West line for 755.07 feet; thence N 89°42'10" E for 117.84 feet; thence along a curve to the right having a radius of 200.00 feet, a chord bearing of S 45°17'50" E, a chord distance of 282.84 feet, for an arc distance of 314.16 feet; thence S 0017°50' E for 245.00 feet; thence N 89°42'27" E for 440.00 feet; thence N 0017°33' W for 354.81 feet to a point 1300.00 feet south of the North line of said Northwest Quarter; thence N 89°42'55" E parallel with said North line for 602.13 feet to a point 1360.00 feet East of said West line; thence S 0017°50' E parallel with said West line for 665.00 feet; thence S 89°42'55" W parallel with the North line of said Northwest Quarter for 1360.00 feet to a point on said West line and the Point of Beginning.
