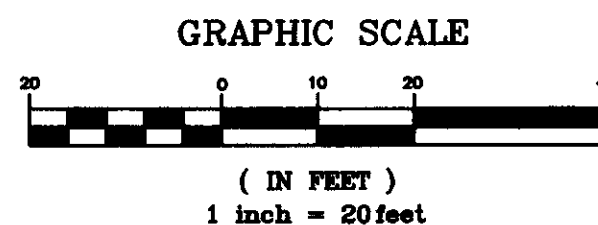


ONE STEP FINAL PLAT OF 21st AND AMIDON ADDITION WICHITA, SEDGWICK COUNTY, KANSAS

I, the undersigned Licensed Land Surveyor in aforesaid county and state, do hereby certify that, under the supervision of the undersigned, we, Poe & Associates, Inc., have surveyed and platted "21st AND AMIDON ADDITION", Wichita, Sedgwick County, Kansas and that the accompanying plat is a true and correct exhibit of the property surveyed, described as follows:

The East 1/2 of a square acre of ground located in the Northwest corner of the following tract of land: Beginning at the Northwest corner of Gov. Lot 2 in Section 7, Township 27 South, Range 1 East of the 6th P.M., Sedgwick County, Kansas; thence East on said Section line 1004 feet to the center of a 50-foot County Road; thence with an angle to the right of 84°15' on the center of said County Road for a distance of 731.3 feet; thence with an angle to the left of 86°20' on said County Road and the center of 20th Street in Motor Addition extended West 266 feet, to the East line of said Lot 2; thence with an angle to the right of 90°20' on the East line of said Lot 2, 1320 feet to the centerline of 18th Street in Motor Addition extended West; thence with an angle to the right of 89°40' on the extended centerline of 18th Street a distance of 1319.6 feet to the West line of said Lot 2; thence with an angle to the right of 90°20' on the West line of said Lot 2, 2086.5 feet to the point of beginning

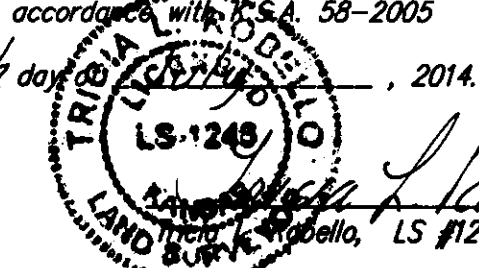
