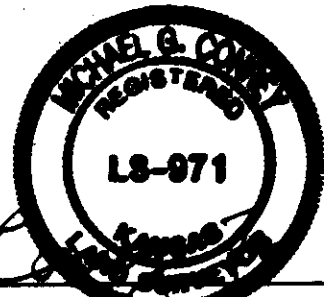

214.53 feet; thence N89°23'26"E parallel with the south line of said North
Half, 325.03 feet to a point on the east line of said North Half; thence
S01°07'16"W along said east line, 450.00 feet to the point of beginning,
subject to road rights-of-way of record.

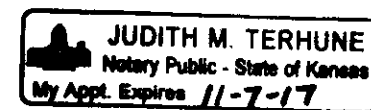

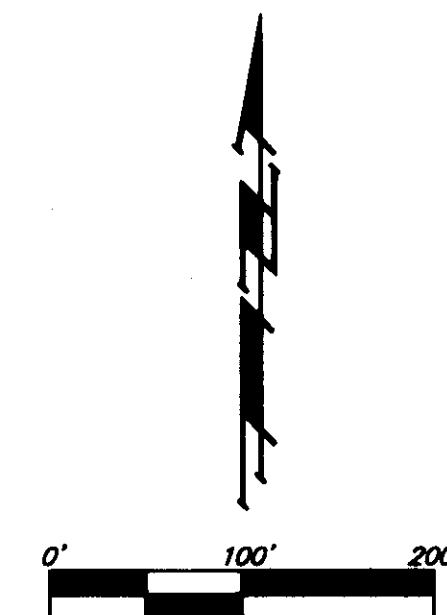

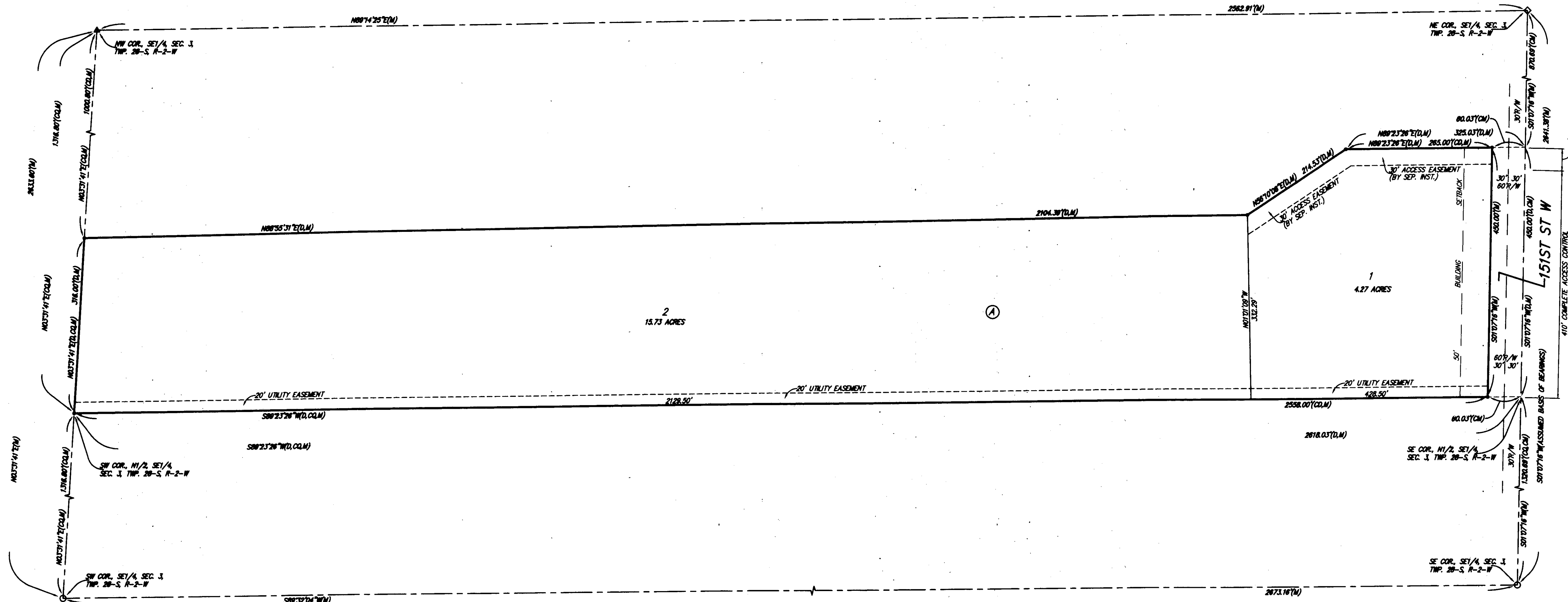
