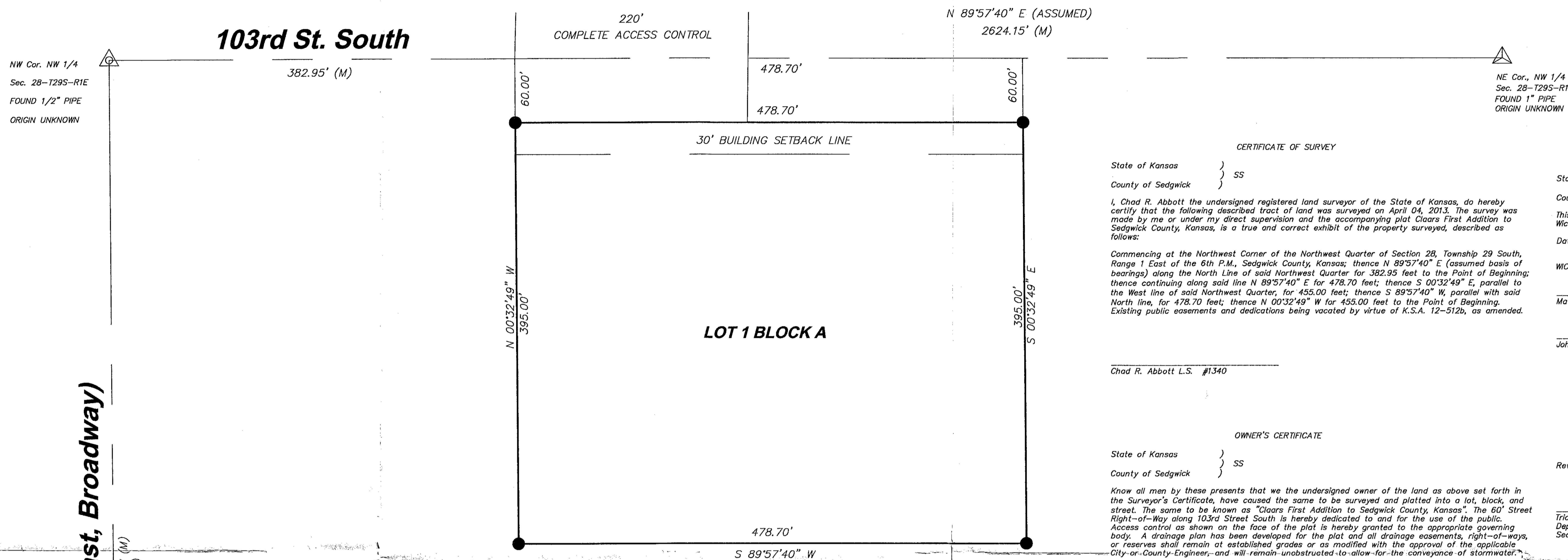

Commencing at the Northwest Corner of the Northwest Quarter of Section 28, Township 29 South, Range 1 East of the 6th P.M., Sedgwick County, Kansas; thence N 89°57'40" E (assumed basis of bearings) along the North Line of said Northwest Quarter for 382.95 feet to the Point of Beginning; thence continuing along said line N 89°57'40" E for 478.70 feet; thence S 00°32'49" E, parallel to the West line of said Northwest Quarter, for 455.00 feet; thence S 89°57'40" W, parallel with said North line, for 478.70 feet; thence N 00°32'49" W for 455.00 feet to the Point of Beginning. 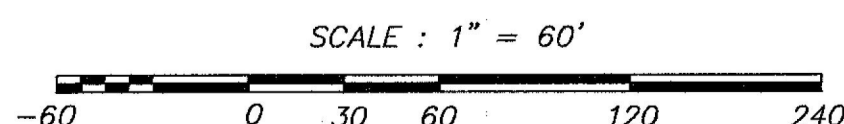
