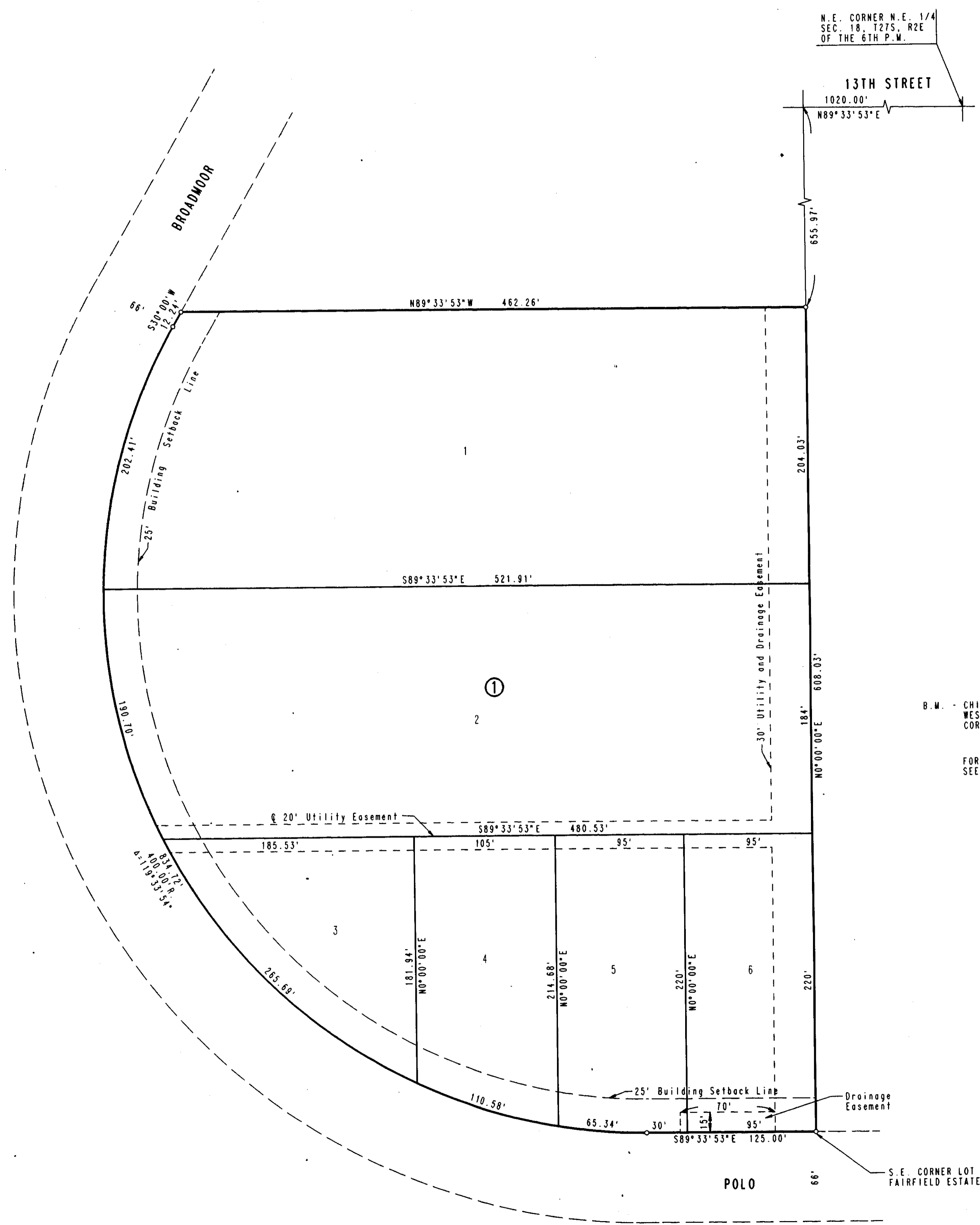

- F. The applicant shall install or guarantee the installation of all utilities and facilities which are applicable and described in Article 8 of the MAPC Subdivision Regulations.
- G. As requested by the applicant, the final plat tracing may combine Lots 5 and 6 into one lot; that is, the final plat tracing may indicate 5 rather than 6 lots.
- H. Perimeter closure computations shall be submitted with the final plat tracing. Section 5-101(c).
- I. Recording of the plat within 30 days after approval by the City Council.

If this plat requires the guaranteeing of improvements a list of the five methods which have been adopted as being acceptable is available through the Planning Department. Also, certificates which are required if petitions are submitted and forms for the bond and irrevocable Letter of Credit are also available from this office.

The enclosed "marked" copy of the final plat is for your information and files.

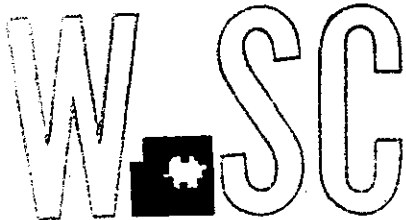

At the regular meeting of the Subdivision Committee of the Metropolitan Area Planning Commission on Thursday, July 8, 1993, the above captioned plat was considered. The action of the Committee was to recommend that this plat be approved subject to:

- A. As requested by City Engineering, the applicant shall submit square footage information and/or an agreement for the redistribution of existing specials. New guarantees shall also be provided for the extension of sanitary sewer and drainage improvements. *day w/ previous lot split*
- B. If improvements are guaranteed by petition, a notarized certificate listing the petitions shall be submitted to the Planning Department for recording.
- C. The applicant is reminded that if this area is to be developed for Office uses, as indicated by the CUP, DP-146, a 35' building setback to Broadmoor/Polo is required, even though a 25-foot building setback is being shown on the plat. The applicant may, however, eliminate the setback from the face of the plat and reference in a note that the setbacks are per the CUP.
- D. The applicant shall submit an avigational easement covering all of subject plat and a restrictive covenant assuring that adequate construction methods will be used to minimize the effects of noise pollution in the habitable structures constructed on subject property.
- E. The applicant's engineer is advised that the Register of Deeds is requiring the name(s) of the notary public, who acknowledges the signatures on this plat, to be printed beneath the notary's signature.
