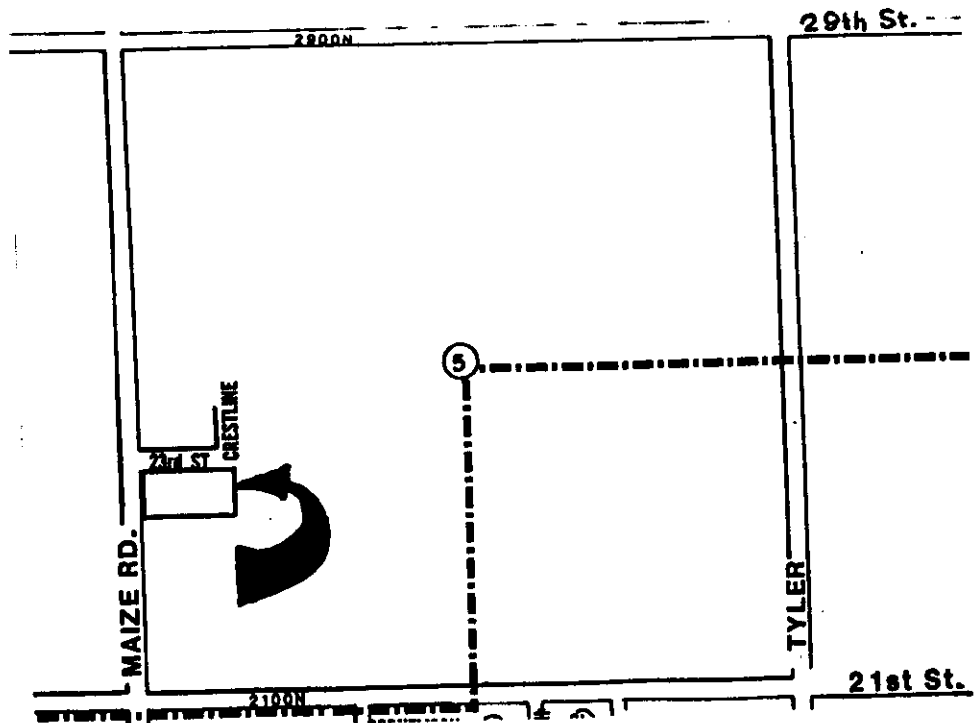

VICINITY MAP:



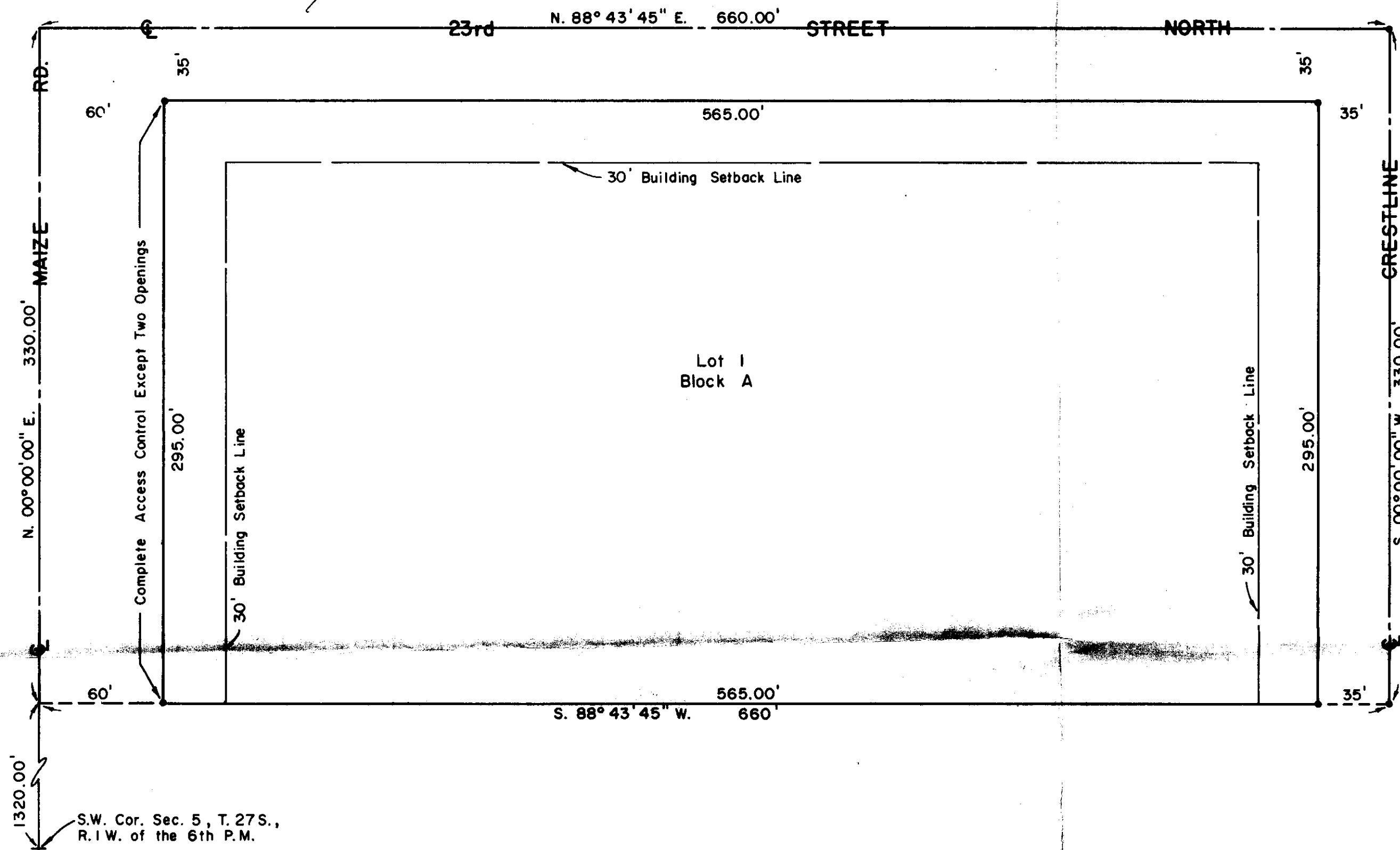
STAFF COMMENTS:

- A. Since neither municipal water nor sanitary sewer is available to serve this property, the applicant shall contact the Environmental Health Division of the Health Department to find out what tests may be necessary and what standards are to be met for approval of on-site sewage facilities and water wells. A memorandum shall be obtained specifying approval.
- B. The applicant shall guarantee any drainage improvements required by the platting of this property.
- C. The applicant shall contact the County Engineer's Office to determine, in conjunction with the Wichita Kennel Club plat to the north if 23rd Street North can be opened up to Suburban Street standards.
- D. The applicant shall submit to City Engineering a petition to be held for development for the extension of municipal water across the front of this plat.
- E. If improvements are guaranteed by petition, a notarized certificate listing the petitions shall be submitted to the Planning Department for recording.
- F. The final plat shall reference in the platdor's text the dedication of access controls to Maize Road across the west line of the plat. The applicant indicate two access openings with the location of the permitted openings to be determined by the appropriate engineer.
- G. On the final plat, the center lines of all perimeter streets shall be labeled.
- H. On the final plat, 30-foot building setbacks shall be indicated to all perimeter streets.
- I. On the final plat tracing, dashed lines shall be used to indicate the street right-of-way being dedicated for Maize and Crestline.
- J. Prior to submitting the final plat tracing, the applicant shall submit a drainage plan to County Engineering for review and approval.
- K. The applicant's engineer is advised that the Register of Deeds is requiring the name(s) of the notary public who acknowledges the signatures on this plat to be printed beneath the notary's signature.

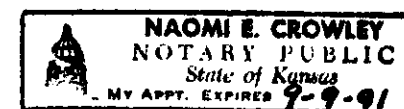

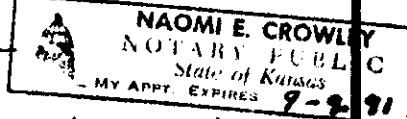
