ORDINANCE NO. 25-833

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

- A. Interstate Highway No. 235 right-of-way between 31st Street South and Meridian Avenue, more fully described as follows:
Beginning at the intersection of the north line of 31st Street South and the east right-of-way line of Interstate Highway No. 235; thence west to the west right-of-way of said Highway; thence southeasterly and easterly along said right-of-way line to the east line of Meridian Avenue; thence north to the north right-of-way line of Interstate 235; thence westerly and northwesterly along said right-of-way line to the point of beginning.
- B. An unplatted tract in the Northeast Quarter of Section 2, Township 28, South, Range 1, East of the 6th P.M., and Oliver Street right-of-way in the Northwest Quarter of Section 1, Township 28, South, Range 1, east of the 6th P.M., adjacent to the tract in the Northeast Quarter of Section 2, more fully described as follows:
Beginning at the intersection of the east line of Oliver Street and the north line of George Washington Boulevard; thence northwesterly along the north line of George Washington Boulevard to a line three hundred (300) feet south and parallel to the south line of Pawnee Avenue; thence east on said line to the east line of Oliver Street; thence south to the point of beginning.
- C. Unplatted tracts in the Northwest Quarter of Section 29, Township 27, South, Range 2, East of the 6th P.M., more fully described as follows:
Beginning at a point on the east line of Eastern Avenue 652.34 feet south of the north line of the Northwest Quarter of Section 29, Township 27, South, Range 2, East of the 6th P.M.; thence east to the east line of said Northwest Quarter; thence south to the southeast corner of said Northwest Quarter; thence west to the east line of Eastern Avenue; thence north to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance No. 25-661 and No. 25-678 be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp. 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
