## ORDINANCE NO. 25-947

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas;

Beginning at the Northeast corner of the Southeast Quarter of Section 26, Township 27 South, Range 1 West; thence south along the Section line 222.75 feet; thence west parallel with the north line of said Quarter Section, 495 feet; thence south parallel with the east line of said Quarter Section 365.2 feet; thence west parallel with the north line of said Quarter Section 3650 feet; thence south parallel with the east line of said Quarter Section 732.2 feet more or less to the south line of the north one-half of said Quarter Section: thence west 402.02 line of the north one-half of said Quarter Section; thence west 492.02 feet, more or less to the west line of said Southeast Quarter; thence west along the south line of the north one-half of the Southwest Quarter of said Section 418 feet; thence north parallel with the east line of said Southwest Quarter 232.704 feet; thence west parallel with the south line of the north one-half of said Southwest Quarter 256.4 feet more or less to a point 171.5 feet east of the easterly right-of-way of more or less to a point 171.5 feet east of the easterly right-of-way of the Wichita-Valley Center Flood Control Project; thence northerly 250.9 feet to a point 165.5 feet east of said project right-of-way line; thence northeasterly 431.7 feet to a point 341.1 feet east of said project right-of-way line; thence northeasterly to the intersection of a line 418 feet west of and parallel with the east line of said Southwest Quarter, intersecting said line 66.6 feet south of the southerly right-of-way of the A.T. & S.F. R.R.; thence continuing on said line to the south line of said Railroad right-of-way; thence northeasterly along said right-of-way to the north line of the Southeast Quarter of said Section 26; thence east 618.25 feet to the place of beginning, platted as West 54 Industrial Addition. trial Addition.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663, 25-678, 25-833, 25-878, 25-893, 26-910, 25-924, 25-939 and 25-946 be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultravires, illegal, or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Afterney be and he is hereby instructed at the proper time to draw an ordinance re-defining the houndaries and limits of the City of wichita. Kansas under and pursuant to G.S. 1959  $S_{\rm D}$  or . 12-517 et sec.

SECTION 5. This ordinance shall take effect and he in force from and after its passage and publication once in the official city paper.
