ORDINANCE NO. 25-959

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND FOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land of Wichita, Kensas:

A. Unplatted tracts in the Northeast Quarter of the Southeast Quarter of Section 26, Township 27 South. Range 1 West of the 6th P.M. more fully described as follows:

Beginning at a point on the west line of West Street 690 feet south of the north line of the Southeast Quarter of Section 26, Township 27 South, Range 1 West of the 6th P.M.; thence west along a line parallel to and 690 feet south of the north line of said Southeast Quarter to a point 495 feet west of the east line of said Southeast Quarter; thence south along a line parallel to and 495 feet west of the east line of said Southeast Quarter a distance of 189.5 feet; thence east along a line parallel to and 879.5 feet south of the north line of said Southeast Quarter to the west line of West Street; thence north to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663, 25-678, 25-878, 25-878, 25-893, 25-910, 25-924, 25-939, 25-946, 25-947, 25-948, 25-956, 25-957, and 25-958, he and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita. Kansas.

SECTION 3. That if any part of portion of this ordinance shall . held or determined to be illegal, ultra vires or void, the same shall not be held or constructed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney he and he is hereby instructed at the proper time to draw an ordinance re-defining the foundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1989 Supp.. 12-117 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
