ORDINANCE NO. 25-982

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A. Unplatted tracts in the Southwest Quarter of the Southeast Quarter of Section 26, Township 27 South, Range 1 West of the 6th P.M. more vully described as follows:

Beginning at the northwest corner of the Southwest Quarter of the Southeast Quarter of Section 26; thence south along the west line of said Southwest Quarter of the Southeast Quarter to the southwest corner of said Southwest Quarter of the Southeast Quarter; thence east a distance of 15 feet; thence north a distance of 264 feet; thence east a distance of 150 feet; thence south 264 feet to a point on the south line of said Southwest Quarter of the Southeast Quarter 165 feet east of the southwest corner of said Southwest Quarter of the Southeast Quarter; thence east to a point 911.87 feet west of the southeast corner of said Southwest Quarter of the Southeast Quarter ithence north along a line parallel to and 911.87 feet west of the east line of said Southwest Quarter of the Southeast Quarter to the north line of said Southwest Quarter of the Southeast Quarter; thence west along said north line to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this brdinance, together with the lands specified and included within Section 1 of Ordinarce Nos. 25-663, 25-678, 25-833, 25-878, 25-893, 25-910, 25-924, 25-939, 25-946, 25-947, 25-948, 25-956, 25-957, 25-958, 25-959, 25-960, 25-961, and 25-981, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or pertion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the houndaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and he in force from and after its passage and publication once in the official city paper.
