ORDINANCE NO. 25-983

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A. Unplatted tracts in the Southeast Quarter of Section 26, Township 27 South, Range 1 West of the 6th P.M. πore fully described as follows:

Beginning at a point on the west line of West Street 383 feet north of the southeast corner of the Northeast Quarter of the Southeast Quarter of Section 26; thence west to a point 299.72 feet west of the east line of said Northeast Quarter of the Southeast Quarter; thence south 123.5 feet; thence west 1845.28 feet; thence south 259.5 feet to the north line of the south half of said Southeast Quarter; thence east along said north line to a point 165 feet west of the northwest corner of the Southeast Quarter of said Southeast Quarter; thence south 904.2 feet; thence east 165 feet to the west line of the Southeast Quarter of said Southeast Quarter; thence enst to the west line of Guarter; thence south to the southwest corner of the Southeast Quarter; thence enst to the west line of Florence Avenue; thence north along said west line to the south line of the north half of said Southeast Quarter; thence east along said south line to a point 299.72 feet west of the east line of the north half of said Southeast Quarter; thence east to the west line to the Southeast Quarter; thence north 243 feet; thence east to the west line of West Street; thence north to the point of teginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-66? 25-678, 25-833, 25-878, 25-893, 25-910, 25-924, 25-939, 25-946, 25-947, 25-948, 25-956, 25-957, 25-958, 25-959, 25-960, 25-961, 25-981, and 25-982, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or constructed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultravires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney he and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and purguant to G.S. 1959 Supp.. 12-517 et seq.

SECTION 5. This ordinance chall take effect and be in force from and after its passage and publication once in the official city paper.
