ORDINANCE NO. 26-004

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A. Unplatted tract in the Northeast Quarter of Section 35. Township 27 South, Range 1 West of the 6th P.M. More fully described as follows:

Beginning at the northeast corner of the Northwest Quarter of the Northeast Quarter of Section 35; thence south to the southeast corner of said Northwest Quarter of the Northeast Quarter; thence west to the west line of the east 6 acres of said Northwest Quarter of the Northeast Quarter; thence north along said west line to the north line of said Northwest Quarter of the Northeast Quarter; thence east to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663, 25-678, 25-833, 25-878, 25-893, 25-910, 25-924, 25-939, 25-926, 25-947, 25-948, 25-956, 25-957, 25-958, 25-959, 25-961, 25-981, 25-982, 25-983, 25-984, 25-985, 26-001, 26-002, and 26-003, be and the same are hereby declared to constitute the lands within the corporate limits and houndaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney he and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1049 Supp., 12-317 et seq.

SECTION 5. This ordinance thall take effect and be in force from and after its passage and publication once in the official city paper.
