AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LLO WITTEN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A. Schmidt Addition, in the Northeast carter of Section 35, Township 27 South, Range 1 West of the 6th P. . more fully described as follows:

Beginning at the point of intersection of the north line of the Northeast Quarter of Section 35 and the west line of Schmidt Addition; thence south along said west line to the southwest corner of said Addition, thence east to the southcast corner of said Addition; thence north along the east line of said Addition to the north line of said Northeast Quarter; thence west to the point of beginning.

SECTION 2.
