AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION :. That the following blocks parcels, pieces and tracts of land be and they are hereby included and brought with: the corporate limits of the City of Wichita, Kansas:

A. An unplatted tract in the Northeast Qualter of Section 35, Township 27 South, Range: West of the 6th P.M. more fully described as follows:

Beginning at the northeast corner of the west 6 acres of the east 12 acres of the Northwest Quarter of the Northeast Quarter of Section 35; thence south to the southeast corner of said west 6 acres; thence west to the Southwest corner of said west 6 acres; thence north to the northwest corner of said west 6 acres; thence east to the point of beginning.
