BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brough within the corporate limits of the City of Wichita, Kansas:

A. Unplatted tracts in the Southwest Quarter of Soction 26, Township 27 South, Range 1 West of the 6th P.M. more fully described as follows:
