ORDINANCE NO. 26-037

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

HE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Mark Control of the C

A. Unplatted tract in the Northwes' Quarter of Section 28. Township 27 South. Range 2 East of the 6th P.M. and U. S. Highway 54 right-of-any adjacent to the unplatted tract, more fully described as follows:

Beginning at thenorthwest corner of the East half of the Northwest Quarter of Section 28; thence south along the west line of said East half 1,320 feet; thence east 495 feet; thence north along a line parallel to and 495 feet east of the west line of said East half to the north line of U. S. Highway 54; thence west along said north line to the west line of the East half of said Northwest Quarter extended from the south; thence south to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663. 25-678. 25-833. 25-878. 25-898. 25-990. 25-924. 25-939. 25-946. 25-947. 25-987. 25-958. 25-959. 25-960. 25-961. 25-981. 25-982. 25-983. 25-984. 25-985. 26-001. 26-002. 26-003. 26-004. 26-005. 26-006. 26-007. 26-008. 26-020. 26-021. 26-022. 26-023. 26-030. 26-031. 26-032. 26.033. be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita. Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void. The same shall not be held or constructed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is herely instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuent to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
