AN ORDINANCE TROVIDING FOR THE INTROVEMENT AND RE-TMPROVEMENT OF KELLOGG AVENUE TROW A FOINT LOO FEET WEST OF THE WEST LINE OF ROCK ROAD, EAST TO THE EAST CITY LIMITS OF WICHITA, AS A MAIN TRAFFICWAY IN THE CITY OF WICHITA, KANSAS.

WHEREAS, The Governing Body of the City of Wichita, Kanass, adopted a Resolution on September 5, 1961, which Resolution was published in the Wichita Evening Eagle and Beacon, the official City paper, six consecutive times, commencing September 8, 1961, maid Resolution being entitled:
