ORDINANCE NO. 26-109

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERE TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Southeast Quarter of Section 20, Township 27 South, Range 2 East or the 6th P.M. more fully described as follows:

Beginning at the point of intersection of the west line of said Southeast Quarter and the north line of Kellogg Avenue; thence north to the Southwest corner of the Northwest Quarter of said Southeast Quarter; thence east to the Southeast corner of the Northwest Quarter of said Southeast Quarter; thence north to the south line of Douglas Avenue; thence east to the west line of Webb Road; thence south to the north line of Kellogg Avenue; thence west to the east right-of-way line of the Kansas Turnpike - U.S. 54 Highway interchange; thence northerly, westerly, and southerly along said Turnpike right-of-way line to the north line of Kellogg Avenue; thence west to point of beginning.

SECTION 2. la. ful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

ORDINANCE NO. 26-110

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Blocks 1, 2, part of 3, 4, 5, 6, 7, 8, 9, 12, 13 and 14, Rainbow Second Addition in Section 9, Township 28 South, Range 1 East of the 6th P.M., Hydraulic Avenue adjacent to said Addition and the Arkansas River adjacent to said Addition more fully described as follows:

Beginning at the intersection of the right bank of the Big Arkansas River and the south line of Galena Street extended from the east; thence east along the south line of Galena Street to a point one hundred thirty-five and two hundredths (135.02) feet east of the west line of Block 3, Rainbow Second Addition; thence southwesterly parallel to and one hundred thirty-five and two hundredths (135.02) feet east of the west line of Block 3 to the north line of Ingalls Street; thence easterly along said north line to the west line of Pattie Avenue; thence south to the south line of Ingalls Street; thence east along said south line to the east line of Victoria Avenue; thence north to the south line of Galena Street; thence east to the east line of Hydraulic Avenue; thence south along said east line to the right bank of the Big Arkansas River; thence westerly and northerly along said right bank to the point of beginning.
