SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp. 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Schnitzler's Addition in the Southwest Quarter of Section 32, Township 26 South, Range 1 East of the 6th P.M. and adjacent street right-of-way, more fully described as follows:

Beginning at the point of intersection of the north line of 29th Street and the west line of Salina Avenue; thence north to the south line of Timmermeyer Gardens; thence east to the center line of Woodland Avenue; thence south to the south line of 29th Street; thence west to the east line of Mileen Acres; thence north to the north line of 29th Street; thence west to point of beginning.

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Lots 1, 3, 5, 7, Block D, Montrose Addition, and unplatted tracts in the Northeast Quarter of Section 5, Township 27 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the northwest corner of Lot 1, Block D, Montrose Park Addition; thence south to the north line of Lot 9, Block D, in said Addition; thence west to the west line of Fairview Avenue; thence south to the center line of Old Chisholm Creek; thence northwesterly and northerly following the meanderings of the center line of said Creek to the south line of 29th Street; thence east along south line to the point of beginning.
