And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp. 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-131

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERE TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Cyrus Sullivan Place Addition in the Southeast Quarter of Section 32, Township 26 South, Range 1 East of the 6th P.M., and adjacent street right-of-way, more fully described as follows:

Beginning at the northwest corner of the south half of the Southwest Quarter of the Southeast Quarter of Section 32; thence east along the north line of said south half to the west bank of the west branch of Chisholm Creek; thence southerly along said west bank line to the south line of 29th Street; thence west along said south line to the west line of the Southeast Quarter of Section 32 extended from the north; thence north to the point of beginning.
