SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-137

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts and the Big Arkansas River in the west half of Section 10, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at a point thirty (30) feet east of the northwest corner of the Northwest Quarter of said Section 10; thence east to a point on the north line of said Northwest Quarter eight hundred thirty (830) feet west of the northeast corner of said Northwest Quarter; thence south five hundred (500) feet; thence east two hundred four (204) feet; thence south to the right bank of the Big Arkansas River; thence southwesterly along said right bank to the east line of Hydraulic Avenue; thence north to the point of beginning.
