

ORDINANCE NO. 26-141

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

- A. Unplatted tracts in the Northeast Quarter of Section 2, Township 28 South, Range 1 West of the 6th P.M., more fully described as follows:

Beginning at the point of intersection of the west line of West Street and the north line of the south half of the Northeast Quarter of Section 2; thence north along said west line to a point five hundred ninety (590) feet south of the intersection of the east line of said Northeast Quarter and the south right-of-way line of the Atchison, Topeka, and Santa Fe Railroad; thence west eight hundred ninety-one and thirty-seven hundredths (891.37) feet to the south right-of-way line of said Railroad; thence southwesterly along said south right-of-way line to the north line of the south half of the said Northeast Quarter; thence east to the point of beginning.

SECTION 2. SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp. 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
