

ORDINANCE NO. 26-142

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THEREIN.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Southwest Quarter of Section 27, Township 27 South, Range 1 West of the 6th P.M., and adjacent U.S. Highway 54 right-of-way, more fully described as follows:

Beginning at a point on the south line of U.S. Highway 54, seventy-five (75) feet east of the west line of the east half of the southwest Quarter of Section 27; thence east along said south line to a point four hundred seventy-five (475) feet east of the west line of the east half of said Southwest Quarter; thence south three hundred forty-five (345) feet; thence east along a line parallel to and three hundred forty-five (345) feet south of the south line of said Highway to a point two hundred six and six-tenths (206.6) feet west of the east line of said Southwest Quarter; thence north to a point on the south line of U.S. Highway 54 two hundred seven (207) feet west of the east line of said Southwest Quarter; thence north to the north line of said highway; thence west along said north line to a point north of the point of beginning; thence south to the point of beginning.

SECTION 2. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
