WHEREAS, such plans, specifications, and estimate of cost have been filed with the City Clerk as provided for by resolution;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That it is hereby declared to be a public necessity to construct a pumping station to provide an outlet for storm water drainage from Storm Water Sewer No. 70 which drains a tract of land generally lying within the following boundaries:

Between Maple Street and Ninth Street from Elder Street to West Street.

SECTION 2. That the cost of construction of such pumping station may be paid from the general fund of said City, or if there be not sufficient money in said fund, improvement bonds shall be issued for the payment thereof to an amount not to exceed the actual cost of said pumping station, all as provided by law and more particularly by Sections 12-626, 12-627, 12-628, and 12-629, General Statutes of Kansas, 1949.

SECTION 3. This ordinance shall take effect and be in force from and after its passage and publication once in the official City paper.

ORDINANCE NO. 26-195

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

F. C. Steck Addition, Gould Gardens, and unplatted tracts in the north half of Section 5, Township 27, South, Range 1, East of the 6th P.M., more fully described as follows:

Beginning at the point of intersection of the east line of Mileen Acres Addition and the south line of 29th Street; thence east along said south line to the center line of old Chisholm Creek; thence southerly along said center line to a point seven hundred fifty-eight and eight-tenths (758.8) feet south of the north line of the Northeast Quarter of Section 5; thence west along a line parallel to and seven hundred fifty-eight and eight-tenths (758.8) feet south of said north line and said line extended to the west line of Arkansas Avenue; thence south along said west line to the north line of the

south half of the Northwest Quarter of said Section 5; thence west along said north line to the east line of the west thirty and twenty-one hundredths (30.21) acres of the Northwest Quarter of said Northwest Quarter; thence north along said east line to the north line of the south sixteen and twenty-one hundredths (16.21) acres of said west thirty and twenty-one hundredths (30.21) acres; thence west to the east line of Moleen Acres Addition; thence north to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-163, 26-169, 26-170, 26-171, 26-186, 26-187, 26-188, 26-189, 26-190, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

County Acres Addition, in the south half of Section 16, Township 27, South, Range 1 West of the 6th P.M., more fully described as follows:

Beginning at the southwest corner of the Southeast Quarter of Section 16; thence north to the northwest corner of the south half of said southeast Quarter; thence west along the north line of the south half of the Southwest Quarter of said Section 16 to the northerly line of School Street; thence northeasterly along said right-of-way line to the easterly line of Country Acres Avenue; thence southeasterly along
