

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or amend any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-117 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-260

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract and part of Tyler Road right-of-way in the Southwest Quarter of Section 16, Township 27, South, Range 1, West of the 6th P. M., more fully described as follows:

Beginning at the northwest corner of the Southwest Quarter of Section 16; thence east along the north line of said Northwest Quarter a distance of one hundred forty-eight (148) feet; thence south parallel to the west line of said Northwest Quarter a distance of one hundred ninety-two and five-tenths (192.5) feet; thence west parallel to the north line of said Southwest Quarter a distance of one hundred eight (108) feet; thence south parallel to and forty (40) feet east of the west line of said Southwest Quarter to a point thirty (30) feet north of the south line of the north half of the north half of said Southwest Quarter; thence west to the west line of said Southwest Quarter; thence north to the point of beginning.

SECTION 2. ORDINANCE NO. 26-261

AN ORDINANCE DESIGNATING DEPOSITORIES OF AND FOR ALL FUNDS AND MONEYS OF THE CITY OF WICHITA, KANSAS, WHICH DEPOSITORIES ARE CERTAIN BANKS LOCATED IN AND AROUND THE CITY OF WICHITA, SEDGWICK COUNTY, KANSAS; DESIGNATING THE APPROXIMATE AMOUNT OF FUNDS WHICH ARE TO BE PLACED IN EACH DEPOSITORY AND DIRECTING THE CITY MANAGER TO ARRANGE FOR THE INVESTMENT IN UNITED STATES GOVERNMENT TREASURY BILLS OF CERTAIN EXCESS FUNDS. THIS ORDINANCE REPEALS ORDINANCE NO. 25-938.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That all funds and moneys of the City of Wichita, Kansas required for current operations shall be placed in demand deposits by the City Treasurer according to law in any one or more of the following banks located in and around the City of Wichita, Sedgwick County, Kansas,

The Boulevard State Bank in Wichita, Kansas;
The Central State Bank in Wichita, Kansas;
The East Side State Bank in Wichita, Kansas;
The First National Bank in Wichita, Kansas;
The Fourth National Bank and Trust Company in Wichita, Kansas;
The Kansas State Bank in Wichita, Kansas;
The Seneca Square National Bank in Wichita, Kansas;
The Southwest National Bank in Wichita, Kansas;
The Stockyards National Bank in Wichita, Kansas;
The Union National Bank in Wichita, Kansas;
The Wichita State Bank in Wichita, Kansas;

SECTION 2. That all funds and moneys so deposited shall, insofar as feasible and practicable, be deposited in the several banks in proportion to the relationship which each bank's capital structure bears to the capital structure of all banks designated as depositories, provided, however, that a sum sufficient to cover the cost of servicing the City of Wichita's accounts be allocated to the bank holding the City's active account before such distribution is made.
