ORDINANCE NO. 26-349

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Northeast Quarter of Section 32, Township 26, South, Range 1, East of the 6th P.M., adjacent street and railroad right-of-way, more fully described as follows:
Beginning at the southwest corner of the northeast quarter of the Northeast Quarter of Section 32; thence north along the west line of the northeast quarter of said Northeast Quarter to the south line of 37th Street; thence east along said south line to a point five hundred forty-two and sixty-four hundredths (542.64) feet west of the west line of Broadway Avenue; thence south eight hundred fifty (850) feet; thence east parallel to the south line of 37th Street a distance of two hundred sixty-six and five-tenths (266.5) feet; thence east to a point on the west line of Broadway Avenue eight hundred fifty and three-tenths (850.3) feet south of the south line of 37th Street; thence east to the east right-of-way line of the Atchison, Topeka and Santa Fe Railroad; thence south along said right-of-way line to the north line of 35th Street; thence west to the east line of Broadway Avenue; thence north to the south line of the northeast quarter of said Northeast Quarter extended from the west; thence west to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-163, 26-169, 26-170, 26-171, 26-186, 26-187, 26-188, 26-189, 26-190, 26-195, 26-196, 26-197, 26-228, 26-229, 26-230, 26-233, 26-234, 26-235, 26-236, 26-237, 26-238, 26-246, 26-247, 26-248, 26-249, 26-250, 26-255, 26-256, 26-257, 26-258, 26-259, 26-260, 26-265, 26-266, 26-267, 26-268, 26-269, 26-271, 26-282, 26-283, 26-284, 26-285, 26-286, 26-310, 26-311, 26-312, 26-313, 26-347, 26-348, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-350

AN ORDINANCE APPORTIONING AND ASSESSING THE COST OF EXCAVATING, AND PAVING THE ALLEY NORTH OF CENTRAL AVENUE FROM THE EAST LINE OF ESTELLE AVENUE TO THE WEST LINE OF VOLUTSIA AVENUE IN THE CITY OF WICHITA, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the cost of excavating, and paving the Alley North of Central Avenue from the East Line of Estelle Avenue to the West Line of Volutsia Avenue in the City of Wichita, Kansas, which is chargeable to private property owners has been ascertained to be \$2,737.02, and the payment of each lot, piece and parcel of land liable for the cost of said improvement has been equalized on all lots, pieces and parcels of land lying between said alley and the platted streets next adjacent thereto on either side of the alley, for the distance to be paved, in the proportion hereinafter set out, now

THEREFORE there is hereby apportioned and assessed to pay the cost of said improvement, the following named sums on the following described lots, pieces and parcels of land liable therefor in said paving district.

A copy of which appraisalment, with words and figures is hereto attached and marked Exhibit "A" and made a part hereof, the same being the report of the appraisers, appointed thereon, and with the names of the owners of the described property erased, and said report having been approved by the Board of Commissioners on February 27, 1962.
