#### ORDINANCE NO. 26-594

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas;

Lots 45, 47, and 49, Block 2; Lots 25, 27, 29, and 31, Block 7; Lots 22, 24, 36, and 39, Block 8, Burton Car Addition, in the Northwest Quarter of Section 33, Township 26, South, Range 1, East of the 6th P. M., more fully described as follows:  
Beginning at a point six hundred eighty-four and sixteen hundredths (684.16) feet, more or less, south and one thousand ninety-four and eighty-two hundredths (1094.82) feet, more or less, east of the northwest corner of the Northwest Quarter of Section 33, said point being the intersection of the west line of St. Francis Avenue and the north line of 36th Street; thence north along the west line of St. Francis Avenue a distance of seventy-four and forty-three hundredths (74.43) feet; thence west one hundred forty and four-tenths (140.4) feet, more or less; thence south seventy-four and four-tenths (74.4) feet, more or less, to the north line of 36th Street; thence east one hundred forty and thirty-nine hundredths (140.39) feet to the point of beginning; being Lots 45, 47, and 49, Block 2, Burton Car Addition.  
Also, beginning at a point one thousand one hundred forty-one and twelve hundredths (1141.12) feet, more or less, south and one thousand ninety-six and four-tenths (1096.4) feet, more or less, east of the northwest corner of the Northwest Quarter of Section 33; thence north along the west line of St. Francis Avenue a distance of ninety-nine and twenty-four hundredths (99.24) feet, more or less; thence west a distance of one hundred thirty-nine and nine-tenths (139.9) feet, more or less; thence south a distance of ninety-nine and two-tenths (99.2) feet, more or less; thence east a distance of one hundred thirty-nine and sixty-three hundredths (139.63) feet, more or less, to the point of beginning; being Lots 25, 27, 29, and 31, Block 7, Burton Car Addition.  
Also, Beginning at a point nine hundred ninety-one and ninety-three hundredths (991.93) feet, more or less, south and one thousand one hundred fifty-five and eight-tenths (1155.8) feet; more or less, east of the northwest corner of the Northwest Quarter of Section 33; thence south along the east line of St. Francis Avenue a distance of forty-nine and sixty-four hundredths (49.64) feet, more or less, thence east a distance of one hundred forty (140) feet, more or less;

thence north a distance of forty-nine and sixty-six hundredths (49.66) feet, more or less; thence west a distance of one hundred forty and one-tenth (140.1) feet, more or less, to the point of beginning; being Lots 22 and 24, Block 8, Burton Carr Addition.

And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
