

thence right at ninety (90) degrees a distance of two hundred sixty-five (265) feet; thence left at ninety (90) degrees a distance of two hundred ninety-four and seventy-eight hundredths (294.78) feet to the west line of said Northwest Quarter; thence north a distance of sixty (60) feet to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-925, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-927

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Northwest Quarter of Section 20, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the southwest corner of the north half of the Northwest Quarter of Section 20; thence east along the south line of the north half of said Northwest Quarter to the west right-of-way line of the Midland Valley Railroad; thence northerly along said right-of-way line to the north line of the south half of the north half of said Northwest Quarter; thence west along said north line to a point one thousand two hundred seventy-four and five-tenths (1274.5) feet east of the west line of said Northwest Quarter; thence south parallel to said west line to a point three hundred thirty (330) feet north of the south line of the north half of said Northwest Quarter; thence

west parallel to said south line a distance of one thousand two hundred seventy-four and five-tenths (1274.5) feet to the west line of said Northwest Quarter; thence south a distance of three hundred thirty (330) feet to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-921, 26-922, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

ORDINANCE NO. 26-928

AN ORDINANCE LEVYING ASSESSMENTS ON LOTS, PIECES AND PARCELS OF LAND IN THE CITY OF WICHITA, KANSAS, FOR THE PURPOSE OF PAYING A PORTION OF THE COST OF CONSTRUCTING AN EIGHT INCH WATER MAIN IN MC COMAS AVENUE FROM IRVING AVENUE TO HARRY STREET, IN IRVING AVENUE FROM WEST STREET TO MC COMAS AVENUE, AND IN WALKER AVENUE FROM MC COMAS AVENUE FOUR HUNDRED EIGHTY FEET EAST, AND A FOUR INCH WATER MAIN IN MC COMAS AVENUE FROM IRVING AVENUE TWO HUNDRED SIXTY-FOUR FEET NORTH, AS AUTHORIZED BY RESOLUTION OF THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS.

WHEREAS, pursuant to proceedings regularly had according to law, contracts have been let for the following improvement in the city of Wichita, Kansas:

Construction of an eight inch water main in McComas Avenue from Irving Avenue to Harry Street, in Irving Avenue from West Street to McComas Avenue, and in Walker Avenue from McComas Avenue 480 feet east, and a four inch water main in McComas Avenue from Irving Avenue two hundred sixty-four feet north,

and such contracts have been duly performed, and

WHEREAS, the Governing Body has determined that the total cost of such improvement is \$15,601.14, and that 85.8081 per cent (\$13,387.04) thereof be assessed against the improvement district and 14.1919 per cent (\$2,214.10) be paid by the City at large; and
