

SECTION I. That Section 11.40.170 of the Code of the City of Wichita, Kansas, shall read as follows:

- (a) Any person who drives any vehicle in willful or wanton disregard for the safety of persons or property is guilty of reckless driving.
 (b) Every person convicted of reckless driving shall be punished upon a first conviction by imprisonment for a period of not less than five (5) days nor more than ninety (90) days, or by a fine of not less than twenty-five dollars (\$25) nor more than five hundred dollars (\$500), or by both such fine and imprisonment, and on a second or subsequent conviction shall be punished by imprisonment for not less than ten (10) days nor more than six (6) months, or by a fine of not less than fifty dollars (\$50) nor more than five hundred dollars (\$500), or by both such fine and imprisonment.

SECTION II. Section 11.40.170 of the Code of the City of Wichita, Kansas, is hereby repealed.

SECTION III. This ordinance shall take effect and be in force from and after its publication in the official City newspaper.

ORDINANCE NO. 26-934

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Northeast Quarter of Section 36, Township 26 South, Range 1 West of the 6th P.M., more fully described as follows:

Beginning at the northeast corner of the Northeast Quarter of Section 36; thence west along the north line of said Northeast Quarter a distance of five hundred sixty-five and seven-tenths (565.7) feet; thence south parallel to the east line of said Northeast Quarter a distance of seventy-seven (77) feet; thence east parallel to the north line of said Northeast Quarter a distance of five hundred sixty-five and seven-tenths (565.7) feet to the east line of said Northeast Quarter; thence north a distance of seventy-seven (77) feet to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-925, 26-926, 26-927, 26-929, 26-930, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-935

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts and Interstate Highway 235 right-of-way in the Northeast Quarter of Section 36, Township 26 South, Range 1 West of the 6th P. M., more fully described as follows:

Beginning at the point of intersection of the north line of the Northeast Quarter of Section 36 and the east right-of-way line of Interstate Highway 235; thence south along said east right-of-way line a distance two hundred forty-seven (247) feet; thence east parallel to the north line of said Northeast Quarter to the west line of Edwards Avenue; thence south along said west line to the north line of Meridian Gardens Addition; thence west along said north line to the west line of Interstate Highway 235; thence northerly along said right-of-way line to the north line of said Northeast Quarter; thence east to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 26-918, 26-919, 26-920, 26-925, 26-926, 26-927, 26-929, 26-930, 26-934, be and the same are hereby declared to constitute the limits within the corporate limits and boundaries of the City of Wichita, Kansas.
