ORDINANCE NO. 26-935

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts and Interstate Highway 235 right-of-way in the Northeast Quarter of Section 36, Township 26 South, Range 1 West of the 6th P. M., more fully described as follows:

Beginning at the point of intersection of the north line of the Northeast Quarter of Section 36 and the east right-of-way line of Interstate Highway 235; thence south along said east right-of-way line a distance two hundred forty-seven (247) feet; thence east parallel to the north line of said Northeast Quarter to the west line of Edwards Avenue; thence south along said west line to the north line of Meridian Gardens Addition; thence west along said north line to the west line of Interstate Highway 235; thence northerly along said right-of-way line to the north line of said Northeast Quarter; thence east to the point of beginning.
