That the Mayor by and with the consent of the Board of Commissioners shall appoint three disinterested appraisers, who shall proceed to appraise such lots and pieces of land as shall be liable for said special improvements, being all of the lots and pieces of land in said sewer benefit district as described in Ordinance No. 24-495 and that the said appraisalment shall be returned to this Commission at their first meeting after the same has been completed.

SECTION 3. This ordinance shall take effect and be in force from and after its passage and publication once in the official City paper.

ORDINANCE NO. 27-131

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN
BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN
THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA,
KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY
OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Part of J. B. Muller Addition, in the Northeast Quarter of Section 29, Township 26 South, Range 1 East of the 6th E. M., more fully described as follows:

Beginning at a point on the west line of the Northeast Quarter of Section 29 one thousand three hundred thirty-two and sixty-four hundredths (1332.64) feet north of the southwest corner of said Northeast Quarter; thence north along said west line a distance of one hundred forty (140) feet; thence east parallel to the south line of said Northeast Quarter a distance of five hundred seventy-five (575) feet; thence north parallel to the west line of said Northeast Quarter a distance of one hundred fifty (150) feet; thence east parallel

to the south line of said Northeast Quarter to the westerly right-of-way line of the Chisholm Creek Diversion; thence southerly along said right-of-way line to a point one thousand four hundred forty-two and nine-tenths (1442.9) feet north of the south line of said Northeast Quarter, said point being on the north right-of-way line of 43rd Street; thence westerly along said right-of-way line to the point of beginning.

That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1961 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
