ORDINANCE NO. 27-441

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Northeast Quarter of Section 30 and the west half of Section 29, Township 26 South, Range 1 East of the 6th P. M., more fully described as follows:

Beginning at the southwest corner of Government Lot 6, in the Northwest Quarter of Section 29; thence east along the south line of said Government Lot 6 and the south line of Government Lot 5, in said Northwest Quarter, to the easterly right-of-way line of the Wichita-Valley Center Flood Control Project; thence south-easterly along said right-of-way line to the east line of the west half of Section 29; thence south along said east line to the northerly right-of-way line of Interstate Highway 235; thence westerly along said right-of-way line to the west line of said Section 29; thence north along said west line to a point three hundred thirty (330) feet south of the south line of Government Lot 3, in the Northeast Quarter of Section 30; thence west parallel to said south line a distance of six hundred sixty (660) feet; thence north a distance of three hundred thirty (330) feet to the south line of said Government Lot 3; thence east along said south line a distance of six hundred sixty (660) feet to the point of beginning.

SECTION 2. SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or amend any terms or provisions hereof which may be legal or lawful. And in the event this ordinance is in whole or in part held to be ultra vires, illegal or void, then it shall nevertheless be held to be valid and lawful to the extent that it shall be held to be those heretofore contained therein.

SECTION 4. That the City Clerk, or his duly authorized representative, be and he is hereby instructed at the proper time to draw an ordinance as herein provided for and publish the same in the City of Wichita, Kansas under and subject to the provisions of the City Charter.

SECTION 5. That this ordinance shall take effect and be in force from and after its passage and publication in the official city paper.

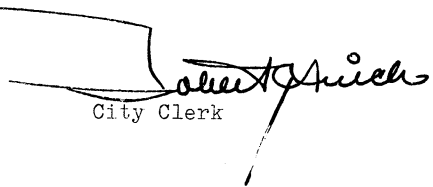

ORDINANCE NO. 27-442

AN ORDINANCE CREATING A SEWER DISTRICT FOR THE CONSTRUCTION OF A LATERAL SEWER; DEFINING, FIXING AND DETERMINING THE BOUNDARIES OF SAID BENEFIT DISTRICT LIABLE FOR SPECIAL ASSESSMENTS FOR THE COST OF THE CONSTRUCTION OF LATERAL 3, WESTLINK SEWER.

WHEREAS, by resolution dated April 30, 1963, the City Engineer of the City of Wichita was directed to prepare a description of the lands properly coming within the sewer district for the construction of a lateral sewer; and,

WHEREAS, the City Engineer pursuant to such instructions filed a description of such lands in the office of the City Clerk of the City of Wichita, on the 3rd day of December, 1963;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That there be and is hereby created a sanitary sewer district which shall be known as Lateral 3, Westlink Sewer, and that the benefit district liable for special assessments for the cost of construction of such sewer shall be defined, fixed and determined as follows:

All the lots in Block 9, Westlink Village 5th Addition.

SECTION 2. That the cost and expense of constructing said Lateral 3, Westlink Sewer, shall be chargeable to and paid by the owners of the lots and tracts of land as defined in Section 1 hereof, regardless of assessments of any sewer or sewer heretofore levied thereon and each part, piece and parcel of said lands within said district shall be assessed its proper share and portion of the cost of the construction of said Lateral 3, Westlink Sewer, as above provided and shall be certified by the City Clerk to the County Clerk to be placed upon the tax rolls for collection in the same manner as other taxes.

SECTION 3. That pursuant to law negotiable bonds of the City of Wichita, shall be issued to pay the cost of construction of said sewer and the amount thereof shall be chargeable to the benefit district as determined herein and assessed against the specified property located therein, in accordance with law.

SECTION 4. This ordinance shall take effect and be in force from and after its passage and publication once in the official City paper.
