

ORDINANCE NO. 27-941

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERE TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the NE $\frac{1}{4}$ of Section 11, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the point of intersection of the south line of 31st Street South and the west line of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 11; thence south along said west line to a point 390 feet south of the north line of the NE $\frac{1}{4}$ of said Section 11; thence east parallel to said north line a distance of 360 feet; thence north to the south line of 31st Street South; thence west along said south line a distance of 360 feet to the point of beginning.

SECTION 2. That the land specified and included in Section 1 of this Ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 27-461, 27-918, 27-939 and 27-940 be and same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this Ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this Ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to G.S. 1963 Supp., 12-517 et seq.

SECTION 5. This Ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 27-942

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the NE $\frac{1}{4}$ of Section 1, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at a point on the south line of 31st Street South, 165 feet west of the east line of the NE $\frac{1}{4}$ of Section 11; thence west along said south line to a point 360 feet east of the west line of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Section 11; thence south parallel to said west line to a point 264 feet south of the north line of said NE $\frac{1}{4}$; thence east parallel to said north line to a point 165 feet west of the east line of said NE $\frac{1}{4}$; thence north to the point of beginning.

SECTION 2. That the land specified and included in Section 1 of this Ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 27-461, 27-918, 27-939, 27-940, and 27-941 be and same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this Ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this Ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to G.S. 1963 Supp., 17-213 et seq.

SECTION 5. This Ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
