

and obnoxious vegetation through the use of soil sterilants and herbicides, the city will proceed to abate the nuisance and levy an assessment against the property for the cost of such abatement."

Upon expiration of fifteen days after publication of the notice, the Director of Public Works shall cause to be cut any weeds and obnoxious growths of vegetation over eighteen inches high on lots and pieces of land and in the streets and alleys located in the city and abate the nuisance created thereby. The charge for such cutting shall be \$18.00 per hour for use of tractor mower; \$4.20 per hour for hand cutting; a minimum charge of \$5.00 per lot; and shall be certified by the Director of Public Works to the City Clerk who shall cause such charges to be assessed against the particular lots or pieces of land from which the weeds or obnoxious growths or vegetation were cut and against the particular lots or pieces of land in front of or abutting upon the street or alley from which weeds or obnoxious growths of vegetation were cut.

SECTION 2. That the original of Section 7.40.070 of the Code of the City of Wichita, Kansas, is hereby repealed.

SECTION 3. That this ordinance shall take effect upon its passage and publication once in the official city paper.

ORDINANCE NO. 28-654

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT OBTAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Part of Government Lot 3 in the Southeast Quarter of Section 21, Township 26, South, Range 1, West of the 1st P. M., more fully described as follows:

Beginning at a point on the south line of Government Lot 3 in the Southeast Quarter of Section 21, one thousand two hundred ninety-nine and sixty-four (1299.64) feet west of the east line of said Southeast Quarter; thence west along said south line six hundred eighty-seven and fifty-nine hundredths (687.59) feet to the east near high bank of the Arkansas River; thence northerly along said high bank to the north line of said Government Lot 3; thence east along said north line four hundred thirty and eighty-five hundredths (430.85) feet; thence north four (4) degrees thirty-four (34) minutes east, one thousand three hundred thirty-three and nineteen hundredths (1333.19) feet to the point of beginning.

SECTION 2. That the land specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 28-432, 28-453, 28-460, 28-471, 28-485, 28-488, 28-489, 28-614, 28-615, 28-616, and 28-634, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

AN ORDINANCE AMENDING SECTION VIII OF ORDINANCE NO. 28-441 OF THE CITY OF WICHITA, KANSAS, WHICH ORDINANCE PROVIDES FOR A UNIFORM PAY PLAN ON SALARY RANGES FOR HEALTH EMPLOYEES FOR THE CITY OF WICHITA, ESTABLISHING POSITION CLASSIFICATIONS FOR ALL APPOINTIVE OFFICERS AND EMPLOYEES OF THE CITY OF WICHITA, AND PRESCRIBING A UNIFORM METHOD DETERMINING SALARY OF POSITION CLASSIFICATION TO THE SCHEDULE OF STANDARD SALARY RANGES (ORDINANCE NO. 27-813) WHICH OUTLINE EXCEPTIONS TO THE REGULAR SALARY ORDINANCE.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION I. That Section VIII of Ordinance No. 28-441 of the City of Wichita, Kansas, be amended to read as follows:

SECTION II. Effective May 1, 1966, the monthly rates for health positions allocated to the titles listed below are prescribed according to the following salary range numbers, subject to the exceptions provided for in Sections XII, XIII, XIV.
