ORDINANCE NO. 29-257

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES OF
THE CITY OF WICHITA, KANSAS, AND RELATING
THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That the following blocks, parcels, pieces and
tracts of land be and they are hereby included and brought within
the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Southwest Quarter of Section 15,
Township 27 South, Range 1 West of the 6th P.M., more
fully described as follows:

Beginning at the northwest corner of the Southwest Quarter
of Section 15; thence east along the north line of said
Southwest Quarter a distance of one thousand five hundred
thirty-seven and six-tenths (1537.6) feet; thence with an
angle to the right of eighty-five (85) degrees zero (0)
minutes thirty (30) seconds a distance of one thousand eight
hundred (1800) feet; thence southeasterly a distance of
eight hundred sixty-two (862) feet, more or less, to a
point on the south line of said Southwest Quarter one
thousand eight hundred fifty-six and forty-three hundredths
(1856.43) feet east of the southwest corner of said South-
west Quarter; thence west along said south line a distance
of one hundred twenty-one and ninety-seven hundredths
(121.97) feet; thence with an angle to the right of
seventy-eight (78) degrees twenty-five (25) minutes
fifteen (15) seconds a distance of seven hundred fifty-
one and fifteen hundredths (751.15) feet; thence with
an angle to the left of eight (8) degrees forty-eight
(48) minutes forty-five (45) seconds a distance of five
hundred twenty-eight and fourteen hundredths (528.14) feet;
thence with an angle to the right of twenty-three (23)
degrees twenty-seven (27) minutes forty-five (45) seconds
a distance of six hundred sixty-three and five-tenths
(663.5) feet, more or less; thence west parallel to the
north line of said Southwest Quarter a distance of three
hundred four and fifty-six hundredths (304.56) feet;
thence with an angle to the left of twenty-six (26)
degrees zero (0) minutes a distance of one hundred
fourteen and five hundredths (114.05) feet; thence with
an angle to the right of forty-one (41) degrees zero (0)
minutes a distance of two hundred fifty-seven and thirty-
eight hundredths (257.38) feet; thence with an angle to
the left of fifteen (15) degrees zero (0) minutes a
distance of two hundred fifty-seven and three-tenths
(257.3) feet; thence with an angle to the right of

seventy-one (71) degrees twenty-six (26) minutes a distance of four hundred forty-eight and seventy-six hundredths (448.76) feet; thence with an angle to the left of seventy-one (71) degrees twenty-six (26) minutes a distance of three hundred ninety-six and thirty-six hundredths (396.36) feet to a point on the west line of said Southwest Quarter three hundred three (303) feet south of the northwest corner of said Southwest Quarter; thence north to the point of beginning.

SECTION 2. That the land specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 28-981 and 29-222,

be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires, or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-517, et seq.


SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

PASSED AND ADOPTED at Wichita, Kansas, this 12th day of April, 1967.


