

ORDINANCE NO. 30-415

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Southwest Quarter of Section 11, Township 28 South, Range 1 East of the 6th P. M., more fully described as follows:

Beginning at the point of intersection of the northerly right-of-way line of the Kansas Turnpike and the left bank of the Arkansas River; thence northerly along said left bank to the south line of the north three (3) acres of Government Lot 2 lying west of the Atchison, Topeka and Santa Fe Railroad right-of-way in the Southwest Quarter of Section 11, Township 28 South, Range 1 East of the 6th P. M.; thence east along said south line to the east line of said Railroad right-of-way; thence north along said east line to the north line of said Southwest Quarter; thence east along said north line to the westerly right-of-way line of the Kansas Turnpike; thence southerly and south-westerly along said right-of-way line to the point of beginning.

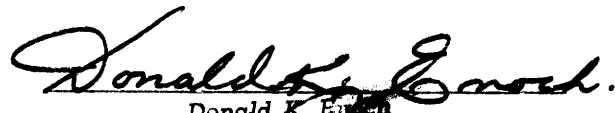
SECTION 2. That the land specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 30-330, 30-356 and **30-414** be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-517, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
