ORDINANCE NO. 30-554

AN ORDINANCE INCLUDING AND INCORPORATING  
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS  
OF LAND WITHIN THE LIMITS AND BOUNDARIES OF  
THE CITY OF WICHITA, KANSAS, AND RELATING  
THERE TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,  
KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land  
be and they are hereby included and brought within the corporate limits of the  
City of Wichita, Kansas:

Unplatted tract in the Southwest Quarter of Section 32, Township 27  
South, Range 2 East of the 6th P. M., and adjacent street right-of-  
way, more fully described as follows:

Beginning at a point on the south line of the Southwest Quarter of  
Section 32, Township 27 South, Range 2 East of the 6th P. M.,  
three hundred twenty-five and sixteen hundredths (325.16) feet  
east of the southwest corner of said Southwest Quarter; thence  
north parallel with the west line of said Southwest Quarter three  
hundred twenty-five and sixteen hundredths (325.16) feet; thence  
west parallel with the south line of said Southwest Quarter to the  
west line of Rock Road; thence south along said west line to the  
south line of said Southwest Quarter extended from the east;  
thence east to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of  
this ordinance, together with the lands specified and included within Section 1  
of Ordinances No. 30-330, 30-356, **30-414, 30-415, 30-533 and 30-534**  
be and the same are hereby declared to constitute the lands within the corporate  
limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held  
or determined to be illegal, ultra vires or void, the same shall not be held or  
construed to alter, change or annul any terms or provisions hereof which may  
be legal or lawful. And in the event this ordinance in its entirety shall be held  
to be ultra vires, illegal or void, then in such event the boundaries and limits  
of said city shall be held to be those heretofore established by law.

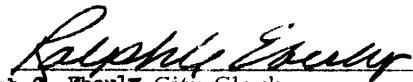
SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-517, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
