

ORDINANCE NO. 31-359

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in Section 32, Township 27 South, Range 1 West of the 6th P. M., and Section 4 and Section 5, Township 28 South, Range 1 West of the 6th P. M., more fully described as follows:

Beginning at the northwest corner of the south half of the Southwest Quarter of Section 4, Township 28 South, Range 1 West of the 6th P. M.; thence east along the north line of the south half of said Southwest Quarter to the east line of said Southwest Quarter; thence south along said east line to the north line of 31st Street South; thence west along said north line to the west line of the east half of the Southeast Quarter of Section 5, Township 28 South, Range 1 West of the 6th P. M.; thence north along said west line to the south line of the Northeast Quarter of said Section 5; thence west along said south line to the west line of said Northeast Quarter; thence north along said west line and said line extended to the north line of Pawnee Avenue; thence west along said north line to the west line of the east half of the Southwest Quarter of Section 32, Township 27 South, Range 1 West of the 6th P. M.; thence north along said west line to a point eight hundred six (806) feet south of the northwest corner of the east half of said Southwest Quarter; thence east parallel to and eight hundred six (806) feet south of the north line of said Southwest Quarter a distance of three hundred seventy-two (372) feet; thence north parallel to and three hundred seventy-two (372) feet east of the west line of the east half of said Southwest Quarter to the north line of said Southwest Quarter; thence west along said north line to a point thirty (30) feet east of the west line of the east half of the Northwest Quarter of said Section 32; thence north parallel to and thirty (30) feet east of said west line a distance of two thousand four hundred twenty-three and forty-five hundredths (2423.45) feet to a point two hundred seven and two hundredths (207.02) feet south of the north line of said Northwest Quarter, said point being the point of curvature of a curve to the left having a radius of three hundred thirty (330) feet; thence north-

westerly along said curve a distance of one hundred forty-one and seventy-one hundredths (141.71) feet to the point of intersection with the west line of the east half of said Northwest Quarter; thence north along said west line to the south line of Harry Street; thence east along said south line to the east line of said Section 32; thence south along said east line and the east line of Section 5, Township 28 South, Range 1 West of the 6th P. M., to the point of beginning.

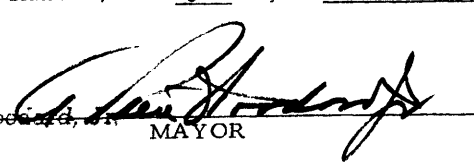
SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 30-894, **31-138, 31-139, 31-140, 31-230 and 31-358** be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-517, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

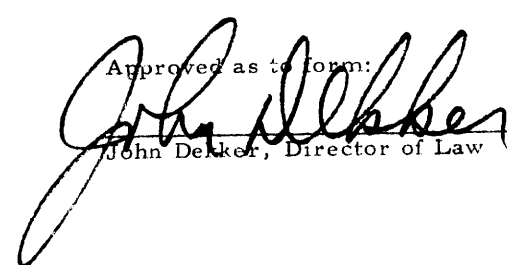
