

ORDINANCE NO. 32-262

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Northeast Quarter of Section 33, Township 26 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at a point on the south line of the Northeast Quarter of Section 33, Township 26 South, Range 1 East of the 6th P.M., fifty (50) feet west of the southeast corner of said Northeast Quarter; thence north parallel to and fifty (50) feet west of the east line of said Northeast Quarter to a point four hundred seventy (470) feet south of the north line of the southeast quarter of said Northeast Quarter; thence west parallel to and four hundred seventy (470) feet south of said north line to the easterly right-of-way line of Interstate Highway I-35W; thence southerly along said right-of-way line to the south line of said Northeast Quarter; thence east to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 31-957, 32-121, and 32-248 and 32-247 be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety
